I. TRANSPORT ECONOMIST

Duration.—One year

Duties.—The expert will be attached to the Planning Division of the Ministry of Works, Communications and Housing and his work will include the following:—

1. to carry out feasibility studies in order to determine the viability of road projects and if applicable, to make comparisons with other road projects to establish their priority;
2. to collect and analyse data pertaining to road planning. Collect statistics on land use, demographic particulars, income distribution, vehicle ownership, operating costs, commodity flows, etc.;
3. to prepare traffic forecasts for road planning purposes. Initiate the collection of and analyse data on construction and maintenance costs, road life, and road sufficiency and in this respect to liaise with the construction and the maintenance sections of the Ministry;
4. to prepare 5-year plans for investment in road projects and develop successive 5-year planning periods;
5. to assist the Chief Planning Engineer in all matters related to highway transportation economics;
6. preparing the feasibility studies of Hoima/Masindi to Kapchorwa Road complex, Olwiyo/Packwach Road, Nabuganyi/Namasagali Road;
7. preparation of road index;
8. International Road Federation Returns;
9. submission of memorandum for technical assistance;
10. re-organisation of the Mechanical Workshop;
11. 5-year Development Plan Review;
12. Budget preparations; and
13. representing the Ministry on the Town and Country Planning Committee for Regional Development.

Qualifications.—The expert should have a basic engineering degree in Civil or Mechanical Engineering followed by postgraduate qualification in Transportation Economics. The expert should have no less than 5 years' experience in Transportation Planning particularly in the field of pre-feasibility studies of highway network construction.

II. DOCUMENTATION ADVISER

Date required.—As soon as possible

Location.—Institute of Public Administration, Kampala

Duration.—2 years

Language.—English

Duties.—To advise on the establishment of a Documentation Centre at the Institute of Public Administration, the main functions of which will be:

- (a) the preparation and maintenance of a comprehensive bibliography on relevant topics on a regular basis;
- (b) to offer a research service in the preparation of reading lists and bibliographies on requested topics;
- (c) the circulation of lists of new material as it becomes available;
- (d) to pinpoint and make contact with new sources of relevant information and research;
- (e) to offer search facilities for specific sources of information and references;
- (f) to provide these services in areas of work relevant to the operation of the business of government.

The basic objective of the Documentation Centre will be to ensure full and efficient utilisation of the Institute Library's resources in teaching, research and policy formulation, by staff and students of the I.P.A. and serving Government officers. It is intended that it will become a valuable information and research centre for all aspects of Government policy.

The establishment of the Documentation Centre in Kampala will be done in close consultation with the Kenya Institute of Administration so as to gradually establish the Centre not only for Uganda but for the whole of East Africa.

The Documentation Adviser would help to train Ugandan staff (and Kenyan staff in Kenya) to operate the Documentation Centre on a continuing basis. Trainees would work with the Adviser and assist in the development of the Centre.

Qualifications and Experience:

- (a) Professional qualification (and/or degree in Librarianship).
- (b) Experience in Institute of Public Administration University/Technical College Libraries in Africa desirable.
- (c) Post-qualification experience in documentation desirable.

III. ADVISER ON PROJECT PLANNING AND MANAGEMENT

Date required.—As soon as possible

Duration.—2 years

Language.—English

Duties.—To provide technical assistance in:

- (a) the development of the field of Project Planning and Management in Commonwealth African countries at all Institutes of Public Administration where the adviser's services are needed;
- (b) the production of teaching materials;
- (c) the sponsoring and encouragement of consultation and co-operation among institutes in the Commonwealth;
- (d) the development of close liaison with societies and associations in Public Administration and related disciplines in Commonwealth countries;
- (e) the maintenance of a balance between academic and practical teaching;
- (f) research in developmental situations, in the frontiers of knowledge in development administration and other young subjects, and in isolating the best teaching methods and qualifying the results of training.

Qualifications:

- (a) appropriate university degree;
- (b) at least five years' teaching experience;
- (c) practical experience in a developing country would be preferable.

Salary Scale and other Benefits.—As far as the salary scales for the above posts are concerned, when on a long-term basis of more than six months, there is an offer of a basic salary between £3,000 to £4,000 per annum, an inducement allowance, where necessary, depending on qualifications and experience, living allowance depending on rent and size of the family, service gratuity of 10 per cent basic salary, children's education allowance, etc. All emoluments are free of tax in the duty country.
