GAZETTE NOTICE
CREATION AND RESERVATION OF SPECIFIED AND
EXCLUSIVE BUS LANES, BUS STOPS AND BUS TERMINALS
FOR USE BY THE BUS RAPID TRANSPORT SERVICE

IN exercise of the power conferred on the Minister responsible for Roads and the Minister responsible for Transport under regulation 133 (1) and (2) of the Road Traffic Regulations, 2012 (L.I. 2180) and acting in consultation with Minister responsible for Roads and Highways, this Notice is given this 5th day of May, 2017.

Creation and reservation of entire route for Bus Rapid Transit System

1. The following are reserved for purposes of the Bus Rapid Transit System:

- (a) southbound lane between Amasaman and Tudu;
- (b) bus stops on southbound lane between Amasaman and Tudu;
- (c) northbound lane between Tudu and Amasaman;
- (d) bus stops on northbound lane between Tudu and Amasaman; and
- (e) the section from the left turn at the Amasaman junction into the Aayalolo terminal at Amasaman.

Southbound bus lane between Amasaman and Tudu

2. The southbound bus lane between Amasaman and Tudu under subparagraph (a) of paragraph 1 comprises

- (a) the section of the N6 from Amasaman to the intersection with the Ring Road at the Kwame Nkrumah Avenue Interchange; and
- (b) the Kwame Nkrumah Avenue from the Interchange to the intersection with the Tudu Road; and
- (c) sections of the southbound route
 - (i) marked by the following road signs both mounted on the same flag pole and placed alongside the road:
 - (A) "No-entry"; and
 - (B) "EXCEPT BRT BUSES"; and
 - (ii) marked with white paint on the surface of the road "BRT BUS LANE"; and ends where the sign "END OF BRT LANE" mounted and placed alongside the road; and

- (d) the inner lane boundary demarcated by continuous white line with yellow rumble blocks affixed on the line and outer edge comprising continuous concrete kerb abutting pedestrian walkway,

and set out in the First Schedule is reserved for the exclusive use of a BRT or a Type B Service Vehicle.

Bus stops on southbound route between Amasaman and Tudu

3. (1) A Bus stop on the southbound lane between Amasaman and Tudu is marked by

- (a) a “bus stop” road sign mounted on a flag pole,
 (b) a green and red bus shelter branded as “Aayalolo”,
 (c) a Red ticket booth branded “Aayalolo”, and
 (d) a bus lay-bye separated into two sections by a concrete kerb demarcator with “BRT BUS STOP” inscribed in a white box marked on the surface of the road in front of the shelter,

as set out in the Second Schedule is reserved for the exclusive use of a BRT or a Type B Passenger Service Vehicle in that section of the bus stop in front of the bus shelter;

(2) Despite subsection (1), a “BUS STOP” inscribed in a white box marked on the road surface in front of the shelter, as set out in the Second Schedule may be shared by the Type B Permit Bus Vehicle with any type of vehicle, but the BRT or Type B Passenger Service Vehicle shall have priority access to the marked bus parking space over other vehicles any time it arrives at the bus stop.

Northbound bus lane between Tudu and Amasaman

4. The northbound bus lane between Tudu and Amasaman under subparagraph (b) of paragraph 1 comprises

- (a) the section of the Kojo Thompson Road from the intersection with the Tudu Road to the Kwame Nkrumah Interchange;
 (b) a section of the N6 from the Kwame Nkrumah Interchange to the terminal at Amasaman;
 (c) the section from the Achimota interchange to the Achimota New Terminal;

- (d) the sections from the Amasaman junction left turn into the Aayalolo terminal at Amasaman
- (e) sections of the northbound route
 - (i) marked by the following road signs both mounted on the same flag pole and placed alongside the road:
 - (A) “No-entry”; and
 - (B) “EXCEPT BRT BUSES”
 - (ii) marked with white paint on the surface of the road “BRT BUS LANE”;

and ends where the sign “END OF BRT LANE” is mounted and placed alongside the road; and

- (f) the inner lane boundary demarcated by continuous white line with yellow rumble blocks affixed on the line and outer edge comprising continuous concrete kerb abutting pedestrian walkway,

and set out in the First Schedule is reserved for the exclusive use of a BRT or a Type B Service Vehicle.

Bus stops on northbound route between Tudu and Amasaman

5. (1) A Bus stop on the northbound lane between Tudu and Amasaman is marked by

- (a) a “bus stop” road sign mounted on a flag pole,
- (b) a green and red bus shelter branded as “Aayalolo”,
- (c) by a red ticket booth branded “Aayalolo”, and
- (d) a bus lay-bye separated into two sections by a concrete kerb demarcator with “BRT BUS STOP” inscribed in a white box marked on the surface of the road in front of shelter,

as set out in the Third Schedule is reserved for the exclusive use of a BRT or a Type B Passenger Service Vehicle in that section of the bus stop in front of the bus shelter.

(2) Despite subsection (1), a “BUS STOP” inscribed in white box marked on the road surface in front of the shelter, as set out in the Third Schedule may be shared by the Type B Permit Bus Vehicle with any type of vehicle but the BRT or Type B Passenger Service Vehicle has priority access to the marked bus parking space over other vehicles any time it arrives at the bus stop.

Interpretation

6. In this Notice, unless the context otherwise requires,

- ‘BRT’ means Bus Rapid Transit and refers to a scheduled bus service that utilises high occupancy buses and has access to extensive bus priority measures, and exclusive bus infrastructure provided under route service contract between GAPTE and a registered bus operating company;
- “GAPTE” means the Greater Accra Public Transport Executive;
- “Type B Passenger Service” means a medium capacity scheduled bus service that uses high occupancy buses and has limited access to bus priority measures and exclusive bus infrastructure provided under contract between GAPTE and a registered bus operating company; and
- “Type B Service Vehicle” means a large occupancy bus registered with GAPTE for passenger conveyance and other GAPTE-branded vehicles used for support operations in the implementation of the Type B Passenger Service.
