THE PARLIAMENTARY AND PRESIDENTIAL ELECTIONS REGULATIONS

(Cap. 7, Sub. Leg.)

APPOINTMENT OF RETURNING AND DEPUTY RETURNING OFFICERS

IN EXERCISE of the powers conferred by regulation 3 of the Parliamentary and Presidential Elections Regulations, the Supervisor of Elections amends Gazette Notice No. 777 of 1988 by—

- (a) revoking the appointment of Victor Musoga as returning officer for all constituencies in the Machakos District and appointing Joseph Mwalimu Kiti as returning officer;
- (b) revoking the appointment of Silvanus Njiru and Joseph Mungai Kiunga Kange the as returning officer and deputy returning officer for all constituencies in the Kiambu District and appointing Victor Musoga and Silvanus Njiru as returning officer and deputy returning officer respectively;
- (c) revoking the appointment of Peter Mwangi Kamau as deputy returning officer for all constituencies in the Narok District and appointing Gerrishon Githinji as deputy returning officer;
- (d) revoking the appointment of Gerrishon Githinji as deputy returning officer for all constituencies in Laikipia District and appointing Peter Mwangi Kamau;
- (e) revoking the appointment of John Musa Juma as deputy returning officer for all constituencies in the Taita-Taveta District and appointing James Kiongi Mwaura as deputy returning officer.

County Council of Laikipia,
Municipal Council of Nanyuki,
and appoints Peter Mwangi Kamau as the deputy returning officer for all electoral areas within the above-named local authorities;
- (e) revoking the appointment of John Musa Juma as the deputy returning officer for all electoral areas within:
County Council of Taita-Taveta,
Town Council of Voi,
and appoints James Kiongi Mwaura as the deputy returning officer for all electoral areas within the above-named local authorities.
