NOTICE OF PRESIDENTIAL ELECTION

Amendment of Notice

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 12 of the National Assembly and Presidential Elections Act and Regulations 8 and 11 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission amends Gazette Notice No. 4886 of 3rd November, 1992 by deleting paragraphs (b) and (c) and inserting the following new paragraphs:

(b) Nomination papers for the presidential election may be delivered by the candidate personally or his/her proposer or seconder to the Electoral Commission, at Parliament Buildings, Committee Room No. 7, Parliament Road, Nairobi, between the hours of eight o'clock in the morning and one o'clock on the 14th December, 1992.

(c) If the presidential election is contested, the poll shall take place on the 29th December, 1992.

NOTICE OF ELECTION OF MEMBERS OF THE NATIONAL ASSEMBLY

Amendment of Notice

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act and Regulations 8 and 14 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission amends

Gazette Notice No. 4887 of 3rd November, 1992 by deleting paragraphs (b), (c) and (d) and inserting the following new paragraphs:

(b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before the 7th December, 1992.

(c) The day for the nomination for the parliamentary election shall be the 9th December, 1992, and nomination papers may be delivered by candidates to the returning officer at between the hours of eight o'clock in the morning and one o'clock on the 9th December, 1992.

(d) If parliamentary election is contested the poll shall take place on the 29th December, 1992.

THE LOCAL GOVERNMENT ELECTIONS (AMENDMENT) (NO. 2)
RULES, 1992

Amendment of Notice

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 57 of the Local Government Act and rule 12 (3) (b) and (c) of the Local Government Elections Rules, the Electoral Commission amends Gazette Notice No. 4985 of 9th November, 1992, by deleting paragraphs (b) and (c) and inserting the following new paragraphs:

(b) The day for the nomination of candidates for councillors shall be the 9th December, 1992, and nomination papers, which may be collected from the returning officers in whose jurisdiction the electoral areas fall, may be delivered by candidates to the returning officers concerned at between the hours of eight o'clock in the morning and one o'clock on the 9th December, 1992.

(c) If the local authority election is contested the poll shall take place on the 29th December, 1992.
