THE NATIONAL ASSEMBLY AND PRESIDENTIAL ELECTIONS ACT
(Cap. 7)

APPOINTMENT OF REGISTRATION OFFICERS AND ASSISTANT REGISTRATION OFFICERS

IN EXERCISE of the powers conferred by section 3 of the National Assembly and Presidential Elections Act, and regulation 3 (1) of the National Assembly Elections (Registration of Voters) Regulations, the Electoral Commission appoints the persons named in the first and second columns of the schedule to be the registration officers and assistant registration officers, respectively, for all registration units in the electoral areas specified in the third column of the schedule which are within the relevant constituency in the fourth column of the said schedule. The appointment shall be from 27th September, 1993 to 11th October, 1993.
