NOTICE OF ELECTION OF MEMBERS OF THE
NATIONAL ASSEMBLY

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act, and regulations 8 (3) and 14 of the Presidential and Parliamentary

Elections Regulations, 1992, the Electoral Commission gives notice that:

- (a) An election is to be held of members of Parliament to serve in the National Assembly for Turkana Central and Kerio Central constituencies.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Monday, 26th February, 1996.
- (c) The day for the nomination of candidates for the parliamentary election shall be Wednesday, 28th February, 1996, and nomination papers may be delivered to the returning officers between the hours of eight o'clock in the morning and one o'clock in the afternoon on Wednesday, 28th February, 1996.
