**NOTICE OF ELECTION OF MEMBER OF THE  
NATIONAL ASSEMBLY**

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act and regulations 8 (3) and 14 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission gives notice that:

- (a) An election is to be held of a member of Parliament to serve in the National Assembly for Starehe Constituency.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Friday, 22nd March, 1996.
- (c) The day for the nomination of candidates for the parliamentary election shall be Monday, 25th March, 1996, and nomination papers may be delivered by candidates

to the returning officer between the hours of eight o'clock in the morning and one o'clock in the afternoon on Monday, 25th March, 1996.

(d) If the parliamentary election is contested the poll shall be taken on Wednesday, 10th April, 1996.

2. A person guilty of an election offence will be liable to the penalties imposed by the Election Offences Act (Cap. 66), and to the disqualifications imposed by the National Assembly and Presidential Elections Act.
