NOTICE is given to all Senators that pursuant to section 33 (3) of the County Governments Act, 2012 and standing order 68 (1) of the Senate Standing Orders:

I have appointed Tuesday, 13th September, 2016, Wednesday, 14th September, 2016 and Thursday, 15th September, 2016 as days for Special Sittings of the Senate to investigate the matter of the proposed removal from office by impeachment of James Nderitu Gachagua, the Governor of Nyeri County.
