## IT IS ORDERED:

1. THAT a Preservation Order be and is issued prohibiting the transfer, mortgage, attachment, disposal off or any other dealings with property known as Duplex Apartment No. C16, situated on L.R. No. 209/5990/13 Grant No. 18295/9 for a period of six (6) months.
2. THAT an Order be and is issued directing the 2nd Respondent to deposit KSh. 8,800,000 into an escrow account in the joint names of the Assets Recovery Agency and the 2nd Respondent within the next thirty (30) days pending the hearing and determination of this matter.
