IMPORTATION OF SUGAR DUTY FREE

IT IS notified for the general information of the public that in accordance with section 114 (2) of the East African Community Customs Management Act, 2004, and as a consequence of the declaration by the President of the Republic of Kenya and Commander-in-Chief of the Kenya Defence Forces, through Executive Order No. 1 of 2017 that the drought and famine in parts of Kenya is a national disaster, duty shall not be payable on the sugar which will have been loaded into a vessel between 1st September, 2017 and 31st December, 2017, destined to a port in Kenya and consigned to a local sugar miller.

Amendment

- (i) in item (a), by deleting the word “imported” and substituting therefor the words “loaded into a vessel destined to a port in Kenya”;
- (ii) deleting item (b) and substituting therefor a new item (b) as follows—
 - (b) nine thousands metric tonnes of milk powder which will have been loaded into a vessel between 12th May, 2017 and 30th November, 2017, destined to a port in Kenya and consigned to a milk processor with prior authority from Kenya Dairy Board for the importation.

RESTRUCTURING AND REVIEW OF STAFF ESTABLISHMENT IN THE

IT IS notified for the general information of the public that pursuant to Articles 10, 179 (d) and 235 (1) of the Constitution of Kenya, as read with section 31 (d) of the County Governments Act (No. 17 of 2012), the Governor, Bomet County, has appointed an *Ad Hoc* Committee to undertake the restructuring of the County Government organization and review of staff establishment.

The *ad Hoc* committee shall comprise the following—

The terms of reference of the committee are—

- (a) to re-organize the County Government’s structure in line with my manifesto which is focused on lean county public service for efficient service delivery;
- (b) to review the current staff establishment in the County Public Service with a view of reducing the current wage bill and also professionalize the civil service in the County;
- (c) to make recommendations on transformative performance management measures to attain maximum productivity and performance in the County Public Service;
- (d) undertake any other task incidental thereto, as may be assigned by the Governor.

In the performance of its task, the *Ad Hoc* committee—

- (a) shall regulate its own procedure;
- (b) may co-opt not more than three (3) persons who possess relevant expertise skills where it considers necessary;
- (c) shall prepare and submit its work plan and budget;
- (d) shall hold such number of meetings in such places and at such time as it may consider necessary for the discharge of its functions;
- (e) shall provide interim reports for consideration;
- (f) shall submit a final report to the Governor at the end of its term.

The *Ad Hoc* committee shall finalize its tasks within a period of thirty (30) days from the date of gazettelement or such longer period as the Governor may prescribe by notice in the Gazette.

DECLARATION OF VACANCIES IN THE OFFICE OF MEMBERS OF THE
COUNTY ASSEMBLY SERVICE BOARD (2 POSTS)

PURSUANT to section 12 of the County Governments Act, 2012 as read together with sections 8, 9, 47 (3) (d) and the First Schedule of

the County Assembly Services Act, 2017, the County Assembly Service Board of Makueni wishes to declare vacancies for the positions of two (2) members (one man and one woman) of the County Assembly Service Board.

A person is eligible for appointment as a Member of the County Assembly Service Board if they meet the criteria below—

- (a) is Kenyan citizen;
- (b) holds a degree from university recognized in Kenya;
- (c) has at least ten years experience in public affairs; and
- (d) meets the requirements of leadership and integrity in Chapter Six of the Constitution.

Interested persons are required to note that the member of the Board above shall serve on a part time basis and the benefits and emoluments due to them for these positions shall be as determined by the SRC.

Persons who meet the criteria above are required to make a written application, attaching their curriculum vitae, academic certificates and other testimonials and submit the application to the Secretary of the Makueni County Assembly Service Board to be delivered in the office of Clerk of the County Assembly in Wote, Makueni on or not later than close of business on 13th October, 2017.
