NOTICE OF ELECTION OF EIGHT (8) MEMBERS OF THE PHARMACY COUNCIL OF MAURITIUS

Notice is hereby given to all registered pharmacists that the election of eight (8) members of the Pharmacy Council of Mauritius, comprising three (3) members from the public sector; and five (5) members from the private sector, will be conducted by the Office of the Electoral Commissioner **on Saturday the ninth (9th) day of March, 2019**; and that the Returning Officer will receive the nomination of candidates for the said election on **Thursday the twenty-first (21st) day of February, 2019**, next ensuing, between the hours of **10 am and 2 pm** at the Office of the Electoral Commissioner, Level 4, Max City Building, Corner Remy Ollier and Louis Pasteur Streets, Port Louis.

Forms of nomination paper may be obtained **either** from the Registrar, Pharmacy Council of Mauritius, Room No. 1023, 10th floor, Emmanuel Anquetil Building, Port Louis **or** from the Health Director, Queen Elizabeth Hospital, Creve Coeur, Rodrigues, between the hours of 9 am and 3 pm on working days (excluding Saturdays).

Every nomination paper must be supported in writing, by not less than **five (5)** pharmacists and be delivered to the Returning Officer between the said hours of 10 am and 2 pm on **Thursday the twenty-first (21st) day of February, 2019**.

Every nomination paper shall specify the name, address and date of registration of the candidate and also contain a declaration by the candidate that on nomination day:-

- (a) he is a citizen of Mauritius;
- (b) he is a pharmacist having not less than 7 years' experience as pharmacist in Mauritius; and

- (c) (i) he is not subject to any preliminary investigation under section 27;
- (ii) no disciplinary proceedings are being held against him under section 28; and
- (iii) no disciplinary measure has been taken against him during the last 5 years preceding the nomination.

Nomination Papers received by post, fax, email or otherwise will not be considered.
