**POLICE NOTICE**

**PUBLIC MEETING AT ROSE HILL AND  
BEAU BASSIN ON 01 MAY 2019**

In virtue of Section 25(3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made on Tuesday 30 April 2019 and Wednesday 01 May 2019 in Rose Hill and Beau Bassin Divisions.

**ROSE HILL DIVISION**

**Public Meeting at Edward VII Street**

**2. CLOSURE OF ROADS**

As from 1200 hours on 30 April 2019 up to 1500 hours on 01 May 2019 the under mentioned roads will be closed to vehicular traffic:-

- (a) Maurice Cure Street from its junction with Inkerman & Laboudonnais Streets St (Queen) towards Leoville L'Homme;
- (b) R. Boodhun Street (D'Epinay) from S. Soopramanien (Queen) to Inkerman Streets;
- (c) Sunnee Mosque Street (Ex P/Wales) from Labourdonais to Leoville L'Homme Streets.

**3. TWO WAY STREET**

Labourdonais Street from it's junction with Dr Maurice Cure & Gladstone Streets will be converted into a 'Two Way Street' as from 1200 hours on 30 April 2019 up to 1500 hours on 01 may 2019.

**4. TRAFFIC DIVERSION AND PARKING FOR BUSES ON WEDNESDAY 01 MAY 2019**

Routes for Vehicular Traffic and Other Vehicles attending the Meeting:

- (a) Buses coming from Port Louis will be diverted into Dr Maurice Cure Street and will debus passenger at Dar-es-Salaam Square and will park along Celicourt Antelme Street, Rose Hill;
- (b) Buses from the North and East via Reduit along Julius Nyerere Avenue will be diverted into Dr Maurice Cure Street and will debus passengers at Dar-es-Salaam Square to park Telecom parking space, Rose Hill; and

- (c) Buses coming from the South (Southern and Central) will be diverted into Dr Maurice Cure Street and will debus passengers at Dar-es-Salaam Square and will park at the parking space of NPF Building, Rose Hill;
- (d) Buses from the West via Mont Roches (Constituencies 14, 19 & 20) will debus near Junction Labourdonais & Inkerman Streets and will then park along Labourdonais & Captain Bruce Streets and the adjoining streets.

**BEAU BASSIN DIVISION**

**Public Meeting at Dr Reid Street Beau Bassin**

**5. CLOSURE OF ROADS**

As from 0800 hours on 01 May 2019 the under mentioned roads will be closed to vehicular traffic:-

- (a) Dr Reid Street in between Swami Dayanand Street & Pasteur Street except for residents there residing;
- (b) Duperre Street in between Brunet & Dr Reid Streets except for residents there residing;
- (c) Pasteur Street in between Commerson & Dr Reid except for residents there residing; and
- (d) Mahadeo Biltoo Street in between Brunet & Dr Reid Streets except for residents there residing.

**6. TEMPORARY CHANGE IN BUS ROUTE**

Buses for Routes 1 & 1A from Port Louis to St Patrick & Camp Levieux respectively will use Dumat & Pope Henessy Streets to continue normal routes instead of Dr Reid & Pasteur Streets.

**7. JUDICIAL PROCEEDINGS**

Non compliance with these traffic arrangements will entail judicial proceedings.
