AMENDMENT OF REGULATIONS
MADE UNDER THE FISHERIES
ACT, 1973 (ACT 58 OF 1973)

The President has under section 11 of the Sea Fisheries Act, 1973 (Act 58 of 1973), further

amended the regulations promulgated by Government Notice 1912 of 1973 as set out in the Schedule.

SCHEDULE

1. Subregulation (1) of regulation 19 is hereby amended by the substitution in paragraph (e) for the expression "1 October up to and including 18 March in the following year" of the expression "1 September 1990 up to and including 28 February 1991."
2. Regulation 26 is hereby amended by the substitution for subregulation (1) of the following subregulation:

"(1) The owners of fishing boats and factories specified in column 1 of the

Table below shall, during the period 1 March 1990 up to and including 31 August 1990, not catch a greater quantity of pilchard by means of directed catches than the quantity shown opposite their names in column 2 or receive a greater quantity of pilchard caught by means of directed catches than the quantity so shown in column 3 of the said Table: Provided that, in the case of those owners in respect of which both a quantity for catching pilchard and receiving pilchard are so shown, the quota shown in column 3 shall include the quota shown in column 2.
