#### NATURE CONSERVATION ORDINANCE, 1975: NOTIFICATION OF HUNTING SEASON, 1990

It is hereby made known in terms of section 25(2) of the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975), that the President —

- (a) under section 25(1)(a) of the said Ordinance —
- (i) determined the period from 1 June 1990 up to and including 31 July 1990 as the hunting season during which huntable game mentioned in Schedule 5 to the said Ordinance may be hunted in terms of section 30, but subject to the other provisions of the said Ordinance; and
  - (ii) determined the period from 1 August 1990 up to and including 30 September 1990 as the hunting season during which huntable game birds mentioned in Schedule 6 to the said Ordinance may be hunted in terms of section 32, but subject to the other provisions of the said Ordinance; and
- (b) under section 25(3) of the said Ordinance made the hunting seasons referred to in paragraph (a)(i) and (ii), respectively, applicable to the whole of Namibia, excluding the following areas:
- (i) that portion of land defined as Area 1 in Schedule A to Government Notice 2428 of 1972, as amended by Government Notice 322 of 1976, and known as Kaokoland, Area 1;
  - (ii) those portions of land defined as Area 1 and Area 2, respectively, in Schedule E to Government Notice 2428 of 1972, as amended by Government Notice 322 of 1976, and known as Hereroland-East, Area 1 and Area 2;
  - (iii) that portion of land defined in Schedule B to Government Notice 1196 of 1970, and known as Hereroland-West;
  - (iv) that portion of land defined in paragraph (3) of the Second Schedule to Government Notice 122 of 1923, and extended by Government Notice 173 of 1935, Government Notice 182 of 1937, Government Notice 46 of 1938, Ordinance 23 of 1960 and Proclamation 248 of 1962, and known as the Ovitoto Reserve;
  - (v) those portions of land referred to in Schedule 1 to the Namaland Consolidation and Administration Act, 1972 (Act 79 of 1972), as extended by Proclamation AG 39 of 1978, the Namaland Consolidation and Administration Amendment Act, 1979 (Act 15 of 1979), Proclamation AG 71 of 1980, the Namaland Consolidation and Administration Amendment Act, 1986 (Act 4 of 1986), and known as Namaland;
  - (vi) that portion of land defined in Schedule C to Government Notice 2428 of 1972, as amended by Government Notice 165 of 1977, and known as Ovambo;
  - (vii) that portion of land comprising the area east of the meridian of longitude 23°18'00" east, and known as the Caprivi Zipfel;
  - (viii) that portion of land defined as Area 1 in Schedule D to Government Notice 2428 of 1972, and known as Kavango, Area 1; and

- (ix) that portion of land defined in Schedule C to Government Notice 1196 of 1970, and known as Bushmanland.

Notice is hereby given in terms of regulation 3 of the Regulations relating to Veterinary and Para-veterinary Professions promulgated by Government

Notice AG. 76 of 1985, that I await nominations of candidates for the election of 2 members of the South West African Veterinary Council. The nomination day shall be the 28th day after date hereof.

**REMARKS:**
