#### PERI-URBAN DEVELOPMENT BOARD: AMENDMENT OF STANDARD BUILDING REGULATIONS: LÜDERITZ

The President has under section 40 of the Peri-Urban Development Board Ordinance, 1970 (Ordinance 19 of 1970), with effect from 1 April 1990 further amended the Water Supply Regulations set out in the regulations promulgated under Government Notice R.1830 of 1970 and adopted for the peri-urban area of Lüderitz in accordance with section 14 *bis* of the

Standards Act, 1962 (Act 33 of 1962), which adoption was made known by Government Notice 6 of 1975, as set out in the Schedule.

### SCHEDULE

Appendix A to Chapter 10 is hereby amended -

- (a) by the substitution in paragraph (1)(a)(i); (1)(a)(ii); (1)(b) and (1)(c) for the amounts "R6,75"; "6,75"; "R0,68" and "R6,65" of the amounts "R9,70"; "R48,10"; "R0,98" and "R8,40" respectively; and
- (b) by the substitution for paragraphs (2) and (3) of the following paragraph:

#### "(2) MISCELLANEOUS CHARGES
