### ANNOUNCEMENT OF COMMUTAL OF SENTENCES OF DEATH

In terms of sub-article (8) of Article 32 of the Constitution of the Republic of Namibia, I hereby announce that I have on the 2nd May 1991, by virtue of the powers vested in me by sub-article 3(d) of the said Article 32, commuted the death sentence imposed on the accused mentioned in Column 1 of the Schedule hereto, and substitute a sentence of imprisonment in place thereof as set out in Column 2 of the Schedule.

## SCHEDULE

COLUMN 1 NAME OF ACCUSED	COLUMN 2 SUBSTITUTED SENTENCE
1. Wilem Tsibeb	That on the charge of murder the death penalty imposed be substituted with a sentence of 20 years imprisonment and the sentences of 1 and 3 years imprisonment respectively imposed on the other two convictions should run concurrently with the sentence of 20 years imprisonment;
2. Gert Johannes Eiman	That on the charge of murder, the death penalty imposed be substituted with a sentence of 25 years imprisonment and the sentences of 2 years and 6 months imprisonment respectively imposed on the other two convictions should run concurrently with the sentence of 25 years imprisonment;
3. Lukas Matsuib	That on the charge of murder, the death penalty imposed be substituted with a sentence of 23 years imprisonment and the sentences of 15 and 2 years imprisonment respectively imposed on the other convictions should run concurrently with the sentence of 23 years imprisonment;
4. Petrus Simbaranda	<ul style="list-style-type: none"> <li>(i) That the sentences on all charges except those in respect of which the death sentence was imposed, stand;</li> <li>(ii) That on the charge of robbery with aggravating circumstances the death penalty imposed be substituted with a sentence of 10 years imprisonment;</li> <li>(iii) That on charges 3, 4, 5 and 6 the death penalty imposed on each count be substituted with 20 years imprisonment in respect of charge 3, 25 years in respect of charge 4, 25 years in respect of charge 5 and 25 years in respect of charge 6;</li> <li>(iv) That all the sentences run concurrently, save that in respect of charge 6, the sentence be ordered to run after the accused has served 5 years in respect of the other crimes, providing for an effective sentence of 30 years imprisonment;</li> </ul>
