**PROPOSAL THAT A MAIN ROAD BE PROCLAIMED,  
THAT A PORTION OF MAIN ROAD 110 BE CLOSED,  
THAT THE CLASSIFICATION OF A PORTION OF  
MAIN ROAD 110 BE CHANGED, AND THAT DISTRICT  
ROADS BE PROCLAIMED: DISTRICT OF KAVANGO**

In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Kavango -

- (a) a main road be proclaimed on land where no road previously existed as described in Schedule I and shown on sketch-map P1476 by the symbols A-B-C-D-E;
- (b) the portion of main road 110 described in Schedule II and shown on sketch-map P1476 by the symbols A-F be closed;
- (c) the classification of a portion of main road 110 described in Schedule III and shown on sketch-map P1476 by the symbols F-G-H, be changed to district road (number 3427);
- (d) a district road be proclaimed on land where no road previously existed as described in Schedule IV and shown on sketch-map P1476 by the symbols B-F; and
- (e) a district road be proclaimed on land where no road previously existed as described in Schedule V and shown on sketch-map P1476 by the symbols D-G.

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the road to which the proposal refers and other proclaimed, minor and private roads in that area are shown, shall for the full period of thirty days mentioned below lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendent, Kavango, during normal office hours.

Every person having any objection to the above-mentioned proposal is hereby commanded to lodge his or her objection in writing, with the grounds upon which it is based clearly and specifically therein stated, with the Senior Control Officer (Section Proclamations) of the office of the Permanent Secretary: Works, Transport and Communication, Private Bag 12005, Ausspannplatz, 9000, within a period of thirty days from the date of publication of this notice.

From a point (B on sketch-map P1476) generally north-eastwards to a point (F on sketch-map P1476) on main road 110.
