REGIONAL COUNCILS ACT, 1992: BY-ELECTION IN
GOBABIS CONSTITUENCY: DETERMINATION OF DAY
AND PLACE FOR SUBMISSION OF NOMINATIONS
OF CANDIDATES AND POLLING DAY AND NOTIFICATION
OF NAME OF RETURNING OFFICER

Under the powers vested in me by section 50(1) of the Electoral Act, 1992 (Act 24 of 1992), it is hereby made known that -

(a) I have determined, in terms of that subsection -

- (i) Friday, 28 April 1995, as the day on which a public sitting shall be held in respect of the Gobabis constituency for the submission of nominations of candidates for election as a member of the regional council for that constituency;
- (ii) that the said public sitting shall be held at the Magistrate's Court, Gobabis, from 09:00 until 11:00 on that day;
- (iii) that, if a poll becomes necessary in the said constituency for the reason that more than one person shall have been duly nominated at the close of the said sitting, the poll shall be taken on 2 June 1995, commencing at 07:00 and closing at 21:00 on that day;

(b) Mr. Paul Zah, Ministry of Works, Transport and Communication, Windhoek, has been appointed in terms of section 51 of the said Act as returning officer at the election.
