PROCLAMATION OF FARM ROAD 1511 AND DEVIATION OF A PORTION OF TRUNK ROAD 9/1: DISTRICT OF WINDHOEK: REGION OF KHOMAS

It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972) that the Minister has -
- (i) under section 22(1)(a) of the said Ordinance, in the district of Windhoek, proclaimed a road on land where no road previously existed and defined the course thereof as described in Schedule I and shown on sketch-map P1559 by the symbols K-F;
 - (ii) under section 22(1)(c) of the said Ordinance, in the district of Windhoek deviated the portion of trunk road 9/1 described in paragraph (a) of Schedule II and shown on sketch-map P1559 by the symbols A-K-L-M-E, from the route so described and shown, to the route described in paragraph (b) of Schedule II and shown on sketch-map P1559 by the symbols A-B-C-D-E;
- (b) in terms of section 23(3) of the said Ordinance, that the Minister has under section 23(1)(d) of the said Ordinance, declared the road referred to in paragraph (a)(i) to be a farm road.

**DETERMINATION OF TOTAL ALLOWABLE CATCH IN
RESPECT OF ROCK LOBSTER: SEA FISHERIES ACT, 1992**

Under section 15 of the Sea Fisheries Act, 1992 (Act 29 of 1992), and after consultation with the Sea Fishery Advisory Council, I hereby determine that the Total Allowable Catch in respect of rock lobster for the allocation of quotas during the 1995/96 rock lobster season, commencing on 1 November 1995 and ending on 30 April 1996, shall be 250 metric tons, which shall, in relation to each area mentioned in the first column of the table set out below, for the purpose of allocating quotas in respect of the period specified opposite such area in the second column of that table, be apportioned as specified opposite such area in the third column of that table:-

(b) North of Ichaboe sanctuary	01/01/96 - 30/04/96	62,4 metric tons
