ALLIED HEALTH SERVICES PROFESSIONS ACT, 1993: THE HOMOEOPATHIC BOARD: LEVYING OF ANNUAL FEES ON REGISTERED PERSONS

The Minister of Health and Social Services has, upon the recommendation of the Homoeopathic Board, under section 46(1) of the Allied Health Services Professions Act, 1993 (Act 20 of 1993), determined the fees to be paid annually by persons registered with that Board as set out in the Schedule.

SCHEDULE

1. The fees to be paid annually by persons registered as homoeopaths with the Homoeopathic Board under the Allied Health Services Professions Act, 1993 (Act 20 of 1993), are N\$100,00.

2. The fees determined by the Minister as set out in paragraph 1 shall be paid -

- (a) to the Homoeopathic Board; and
- (b) annually in advance before the last day of May of the year in respect of which such annual fee is payable.

3. An annual fee referred to in paragraph 1 which is paid after the date for payment determined by paragraph 2, shall be increased by an amount equal to one-tenth of the amount of the annual fee payable in respect of every month that such annual fee is paid after the date for payment so determined.

4. An annual fee referred to in paragraph 2 which becomes payable at the date of registration of a homoeopath shall, if such date of registration falls after the last day of May of the year in respect of which such annual fee is payable, be decreased by an amount equal to one-twelfth of the amount of the annual fee payable in respect of every month that such registration takes place after such last day of May.

5. For the purposes of paragraphs 3 and 4, a part of a month shall be deemed to be a full month.

It is hereby made known that the Homoeopathic Board has, after consultation with the Council for Health and Social Services, and with the approval of the Minister of Health and Social Services, under section 39 of the Allied Health Services Professions Act, 1993 (Act No. 20 of 1993), determined the tariff of fees set out in the Schedule which may be charged by any registered homoeopath in respect of professional services rendered by him or her in the practice of his or her profession under the said Allied Health Services Professions Act, 1993.

Initial	(- 08002 -)	N\$60.00 for 30 minutes or part thereof
Subsequent	(- 08001/2 -)	N\$40.00 for 30 minutes or part thereof
After hours	(- 08001/2 -)	during the week: N\$90.00 for 30 minutes or part thereof during weekends and public holidays: N\$120.00 for 30 minutes or part thereof
Home visit	(- 08001/2 -)	N\$120.00 per 30 minutes or part thereof, plus N\$1.00 per km from the consulting rooms in respect of travelling expenses.
