AMENDMENT OF REGULATIONS UNDER THE DEPARTURE FROM NAMIBIA REGULATION ACT: DEPARTURE FROM NAMIBIA REGULATION ACT, 1955

Under Section 9A of the Departure from Namibia Regulation Act, 1955(Act No. 34 of 1955) I have made the regulations set out in the Schedule.

SCHEDULE

Definitions

1. In these regulations “the Regulations” means the Regulations made under the Departure from Namibia Regulation Act, 1955 published under Government Notice No. 136 of 29 July 1994, as amended by Government Notice No. 234 of 16 September 2013.

Substitution of regulation 2 and 3 of Regulations

2. The Regulations are amended by the substitution for regulations 2 and 3 of the following regulations:

“Departure from Namibia

2. A person wishing to depart from Namibia, excluding a person referred to in paragraph (b) of section 2 of the Act shall at a port listed in Annexure “B”, present himself or herself to an immigration officer on duty at that port.”.

3. (1) A person referred to in regulation 2 shall, when presenting himself or herself to an immigration officer contemplated in that regulation -

- (a) submit his or her passport or permit, as the case may be, to the immigration officer referred to in regulation 2;
- (b) at the request of the immigration officer, complete and sign a departure form substantially in the form of Annexure “A”; and
- (c) allow the immigration officer to examine his or her luggage or the conveyance which he or she is traveling in.

(2) Subregulation (1)(b) does not apply to a person who is a Namibian citizen or a permanent resident of Namibia, except where the electronic border management system is not functioning at the time of processing that person’s departure from Namibia.”.

SCHEDULE**Definitions**

1. In these regulations “the Regulations” means the Regulations made under the Immigration Control Act 1993, published under Government Notice No. 134 of 29 July 1994, as amended by Government Notice No. 82 of 15 April 2008, Government Notice No. 133 of 1 July 2010, Government Notice No. 145 of 8 September 2014 and Government Notice No. 138 of 13 July 2018.

Amendment of regulation 2 of Regulations

2. The regulations are amended by the addition after subregulation (4) of the following subregulation:

“(5) Subregulation (1) does not apply to a returning resident who is a Namibian citizen or a permanent resident of Namibia, except where the electronic border management system is not functioning at the time of processing that person’s entry into Namibia.”.

Insertion of regulation 2A in Regulations

3. The regulations are amended by the insertion after regulation 2 of the following regulation:

“Port of entry

2A. A person wishing to enter into Namibia in terms of section 6, must enter at any port listed in “Annexure AF” and present himself or herself to an immigration officer on duty at that port.”.
