PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.

2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the Government Gazette office, Private Bag 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than **12h00** on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.

3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.

Having heard **Mr. Visser**, on behalf of the applicant and having read the application for HC-MD-CIV-MOT-EXP-2020/00179 and other documents filed of record:

IT IS HEREBY ORDERED THAT:

1. A *Rule Nisi* is hereby issued calling upon the Respondent(s) to show cause, if any to this Honourable Court, on or before 23/10/2020 at 10:00, why an order should not be made in the following terms:
 - 1.1 recognizing the winding-up order and the winding-up of Chemical Specialities Limited t/a Chemspec, by the High Court of South Africa, Durban granted on 15 August 2015;
 - 1.2 recognizing the appointment of the applicants (in terms of the laws of the Republic of South Africa as joint liquidators of Chemical Specialities Limited (in liquidation) ("Chemspec") upon the terms set out herein, within the Republic of Namibia, until such recognition is withdrawn by order of this Court;

- 1.3 recognising the powers granted to the applicants by the Master of the High Court of South Africa as set out in the applicants' letter of appointment dated 19 November 2015, attached hereto and marked as annexure "A", as being the powers envisaged in sections 386(1),(a), (b), (c), (d) (e), 386(2), 386(2A), 386(2B), 386(3)(a), (b) and (c) read with 386(4)(a) - (i), 386(5) and (6) of the Companies Act, 1973 ("the South African Act");
