#### NOTICE OF PROPOSED AMENDMENTS OF THE NAMIBIAN CIVIL AVIATION REGULATIONS, 2001 (AS AMENDED): PART 187 (CHARGES): CIVIL AVIATION ACT, 2016

1. The Namibia Civil Aviation Authority in terms of Regulation 3.04.3 regarding Regulations Making published as Government Notice No. 293 of 8 November 2018, publishes this notice of intention to make regulations on the revision of Part 187 (Charges) of charges (including fees) in the manner contemplated by Part 9 of the Civil Aviation Act, 2016 (Act No. 6 of 2016) (hereinafter “the Act”).
2. This proposal on amendments to fees is supplementary to the issue of General Notice No. 461 of 5 November 2019 in Government Gazette No. 7039 dated 5 November 2019 setting out the purpose and reasons on the changes and forms part of consultation requirements on regulations-making. The draft version on the proposals is set out in the Schedule to Annexure below.
3. After the expiry of the period for comment(s) the recommendation from the Board will be obtained for the Minister to approve the amendments in the manner required by Part 9 of the Act on insertions/substitutions/deletions of Part 187.

4. Interested persons or groups of persons are invited to submit written comments/submissions, or replies, to comments/submissions, and/or for reconsideration on the current and proposed amendments, to Part 187 of the amended NAMCARS not later than 21 working days from the date of publication of this General Notice.

## SCHEDULE

### Definitions

1. In these regulations, “the Regulations” means the Namibian Civil Aviation Regulations published under Government Notice No. 1 of 2 January 2001 as amended by Government Notice No. 57 of 1 April 2006, Government Notice No. 201 of November 2006, Government Notice No. 80 of 1 April 2017, Government Notice No. 210 of 31 August 2018, Government Notice No. 410 of 30 December 2019, Government Notice No. 89 of 27 March 2020 and Government Notice No. 112 of 30 April 2020.

### Amendment of regulation 1.00.1

2. Regulation 1.00.1 of the Regulations is amended –
  - (a) by the deletion of the definition of “available seat”;
  - (b) by the insertion after the definition of “obstacle” of the following definition:

“occupied seat” means the seat or space on an aircraft occupied for the purposes of passenger use in relation to international or domestic flight providing air services whether scheduled or non-scheduled”;

### Amendment of Part 187 of Regulations

3. Part 187 of the Regulations is amended -
  - (a) in the “List of Regulations “ by the substitution of for the title “187.00.22 Fees and Charges relating to Parts 71,170 to 175 and 179” of the title as “172 air traffic service unit” as “Part 187.00.22”, for the title as “170 Charges relating to air navigation services” as “Part 187.00.22A”, for the title “171 Aeronautical Telecommunications” as “Part 187.00.22B”, for the title as “173 Flight Procedure Design” as Part

187.00.22C”, for the title as “174 Aeronautical Meteorological Services” as “Part 187.00.22D” and for the title as “175 Aeronautical Information Services” as “Part 187.00.22E;

(b) under Part 187.00.23 by the substitution of sub-regulation (1) with the following:

	<b>Civil Aviation Safety Charge:</b>	
	<b>Liability to pay civil aviation safety charge</b>	
187.00.23	(1) A civil aviation safety charge amounting to N\$54.00 per occupied seat for domestic flights and N\$90.00 per occupied seat for international flights providing air services is payable. The safety charge is not payable by infants younger than one (1) year old on date of travel.	<b>N\$54.00 per occupied seat - Domestic flight</b>  <b>N\$90.00 per occupied seat - International flight</b>
	(2) The civil aviation safety charge shall be included in the price payable in respect of the air ticket concerned.	
	(3) Value Added Tax is not payable on the civil aviation safety charge.	
	(4) The civil aviation safety charge becomes due to the Authority by a holder or participant and inclusive of an owner or operator, providing air services on the departure of a flight from an aerodrome within the territory of Namibia.	
	(5) The owner or operator providing air services shall pay, directly to the Authority, the civil aviation safety charge, within 30 days of the invoice date.	
	(6) Information relating to the total number of passengers per departing aircraft per owner or operator on domestic and/or international flights for determination of charge, as contemplated in subregulation (5), shall be provided monthly –  (a) by the Air Navigation Services Unit of the Authority, in respect of flights departing from aerodromes manned by air traffic controllers; and	
	(b) by the relevant aerodrome licence holder or operator in respect of flights departing from aerodromes not manned by air traffic controllers.	
	(7) The Authority shall, on receipt of the information referred to in subregulation (6), verify the accuracy and completeness of data received from the operators of aerodromes involved and Air Navigation Services Unit of the Authority.	
	(8) The owner or operator of the relevant air services shall be subjected to a compliance audit as instructed or done by the Authority at any time determined by the Executive Director.	
	(9) Without prejudice to subregulations (6) and (8) it shall be the responsibility of the aircraft owner or operator providing air services to provide the Authority with correct information on the number of passengers per departures and type of aircraft used in case of conflicting data, for verification purposes.
