NOTICE OF ACTION TO BE TAKEN UNDER SECTION 38: THE NAMIBIAN
COMPETITION COMMISSION // PHARMACEUTICAL SOCIETY OF NAMIBIA
AND OTHERS
(CASE NUMBER: 2018JUN0003COMP)

COMPETITION ACT, 2003
(Section 41, Rule 18(1))

1. The Namibian Competition Commission (“the Commission”) during September 2018 initiated an investigation against the Pharmaceutical Society of Namibia (“the PSN”) and its member pharmacies. The Commission investigated the matter and during January and February 2020 gave notice of its proposed decision.
2. **The Commission gives notice that it intends to take the following action under section 38 of the Competition Act:**
 - 2.1 Following the investigation and consideration of all representations, including the written representations made in terms of section 36 and the matters raised at the conference held in accordance with section 37 of the Competition Act, the

Commission has resolved to institute proceedings in Court against the Respondents for an order:

- 2.1.1 Declaring that the Respondents have contravened section 23(1) read with section 23(2)(a) and section 23(3)(a) of the Competition Act;
- 2.1.2 Ordering the Respondents to cease with the conduct;
- 2.1.3 Restraining the Respondents from engaging in the conduct in future;
- 2.1.4 Seeking an appropriate pecuniary penalty against the Respondents in terms of section 53(1)(a) and 53(2) of the Competition Act, taking into account the factors stated in section 53(3) of the Competition Act;
- 2.1.5 Ordering that the Respondents to pay the costs of the proceedings; and
- 2.1.6 Such further and/or alternative relief as the Court may consider appropriate;

Against:

The following undertakings/association of undertakings, as the Respondents against which relief will be sought in terms of section 38:

- 2.1.7 **The Pharmaceutical Society of Namibia (“the PSN”)**, a voluntary professional association for pharmacists in Namibia, and having its business place at Office No. 14, Gecka Pharma, 32 David Hosea Meroro Drive, Windhoek, Namibia.
- 2.1.8 All relevant pharmacies, as indicated in the “**Annexure A**” document attached hereto.

Both the PSN and the concerned pharmacies will cumulatively be referred to as the “**Respondents**”.

3. The nature of the conduct that is the subject-matter of the action is that:

- 3.1 As part of their business, pharmacies *inter alia* prepare, dispense and sell medicine to patients with or without a doctor’s prescription. The PSN on the other hand, is a voluntary association of pharmacies which exists to *inter alia* protect the welfare of its members.
- 3.2 The Commission’s investigation, submissions received, and evidence uncovered indicate that the PSN has a long-standing mandatory rule that requires pharmacies to impose a 50% mark-up on the dispensing of medicine. The investigation further found that aforementioned rule prohibits pharmacies from deviating from the 50% mark-up. Pharmacies on the other hand, by virtue of becoming members of the PSN submit to the authority of the PSN and are therefore, liable for infringement of the Competition Act. Furthermore, the PSN and its members have agreed to maintain the 50% mark-up pricing structure even when presented with what appeared to be a better alternative.
- 3.3 The Respondents through the PSN, have denied engaging in the conduct and have raised the following primary defenses; That,
 - 3.3.1 The 50% mark-up is not strictly enforced by the PSN nor is it strictly applied by all pharmacies and depending on medication, a 10% mark-up can be applied while in certain remote areas a mark-up can exceed the 50% benchmark to cover the additional cost such as transport.
 - 3.3.2 The 50% markup is a mechanism to determine the price which medical aid funds are prepared to pay for medicine as well as medical aid related services linked to the NAPPI code;

- 3.3.3 A “levy” which is not related to the mark-up is a percentage that each medical aid fund expects its members to pay at the time of receiving a medical service including medicine.
- 3.3.4 The mark-up is variable and ranges from 10 to 100%. If a medical aid scheme has a levy of 20%, on a N\$100 medicine, the levy would be N\$20. If a pharmacy charge N\$102, the levy would be N\$22, however, if the pharmacy were to charge less than the N\$100, say N\$90, then the levy would be N\$18.
- 3.3.5 The 50% mark-up pricing structure is a NAMAF benchmark tariff that is calculated and has been implemented in many years with the objective of sustainability and ensuring that healthcare services are accessible to all Namibians. There are similar practices in other countries such as Botswana, South Africa, Zimbabwe and Angola.
- 3.3.6 Benchmark tariff is a guideline determined by NAMAF as a guideline on pricing for medication. Should NAMAF not provide the benchmark tariffs, the cost of healthcare services would unreasonably escalate.
- 3.4 Based on the grounds set out further down below, the Commission has not been persuaded by the above claims.
- 3.5 The Commission’s investigation has in fact found that:

3.5.1 The market has been correctly defined

- 3.5.1.1 The investigation identified the product market as that of the dispensing of medicine by the pharmacies to patients (consumers) in Namibia, since the 50% mark-up is applicable in respect of the medicine that are dispensed by pharmacies to consumers throughout Namibia. None of the Respondents have disputed the Commission’s market definition.

3.5.2 Evidence of Engaging in the Conduct:

- 3.5.2.1 Despite the arguments by the Respondents, the evidence gathered by the Commission shows that the PSN reprimands pharmacies for charging a mark-up less than 50%. The PSN has also gone as far as making investigation referrals to the Pharmacy Council of Namibia through the Health Professions Council of Namibia (“HPCNA”) against pharmacies that have “offered discounts” on medicine.
- 3.5.2.2 Evidence obtained has also revealed that the PSN and its members met and agreed to keep the 50% mark-up pricing structure in place. Efforts by the Namibian Association of Medical Aid Funds (“NAMAF”) recommending more relevant pricing models were rejected without reasonable justifications.

3.5.3 The 50% mark-up is not a mechanism to determine the price which medical aid funds are prepared to pay

- 3.5.3.1 The 50% mark-up is the margins that pharmacies place on top of the cost for medicine plus VAT. The “sticker price” remains the same whether a medicine is dispensed to a medical aid fund member or “cash consumers”.

3.5.4 The 50% mark-up is not a NAMAFA benchmark tariff and is not determined by NAMAFA

3.5.4.1 Evidence before the Commission shows that the 50% mark-up is not a NAMAFA initiative. In fact, the 50% mark-up predates the existence of NAMAFA and the PSN. However, the PSN in agreement with its members resolved to maintain and continue charging a 50% mark-up when NAMAFA tried to do away with it and proposed a four-tier dispensing fee model.

3.5.5 The PSN and its members' conduct amounts to price fixing

3.5.5.1 The PSN and its members from the start have agreed to adopt the 50% mark-up pricing structure and as such, the PSN has resolved to include a clause in its constitution further cautioning its members against deviating from imposing 50% mark-up. In its own admission, the PSN confirmed that, it has together with its members agreed to maintain the 50% mark-up pricing structure even when a seemingly better alternative was proposed by NAMAFA.

3.5.5.2 In addition, the PSN has taken numerous steps against pharmacies that have deviated from the 50% mark-up pricing structure by giving discounts and waiving co-payments on prescriptions. This conduct automatically qualifies as concerted practices and/or agreements between parties in a horizontal relationship, and a decision by an association of undertakings, to engage in price fixing which is a prohibited conduct in terms of section 23 (1) read with section 23 (2) (a) and section 23 (3) (a) of the Act.

3.5.6 The Respondents have therefore, also failed to provide a justification for the setting and implementation of the 50% mark-up.

3.5.7 No exemption has been sought in terms of Part III of the Competition Act in this matter.

3.5.8 The conduct of the Respondents therefore amounts to a decision, agreements and concerted practices to fix prices and trading conditions as a contravention of section 23(1) read with section 23(2) (a) and 23(3)(a) of the Competition Act.

4. Notwithstanding the above, the Commission records that it is willing to engage with the Respondents with the object of settling the matter in terms of section 40 of the Competition Act and to avoid proceedings in terms of section 38 of the Competition Act.
