THE APPROPRIATION DECREE 1966



Decree No. 28

[21st April 1966]

Commence-
ment.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1.—(1) The Accountant-General may, when authorized so to do by warrants issued by the Federal Executive Council, pay out of the Consolidated Revenue Fund during the year ending on 31st March 1967 the sums specified by the warrants, not exceeding in the aggregate seventy-six million, seven hundred and twenty thousand and forty pounds.

(2) The amount mentioned in the foregoing subsection shall be appropriated to heads of expenditure as indicated in the Schedule of this Decree.

(3) No part of the amount aforesaid shall be issued out of the Consolidated Revenue Fund after the end of the year mentioned in subsection (1) above.

(4) The function of issuing warrants for the purposes of this section shall be deemed to have been delegated by the Federal Executive Council to the Permanent Secretary of the Federal Ministry of Finance.

2. This Decree may be cited as the Appropriation Decree 1966 and shall apply throughout the Federation.
