

**FORFEITURE OF ASSETS (DIRECTOR OF THE
SPECIAL STRUCTURES COMPANY LIMITED)
(AMENDMENT) DECREE 1977**

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1. The Forfeiture of Assets (Director of the Special Structures Company Limited) Decree 1977 is hereby amended as follows :—

(a) in section 1 thereof, immediately after the word "Decree" where it occurs at the end of the section, there shall be added the words "so however that if before the making of this Decree, a deed had been executed between the Federal Mortgage Bank of Nigeria (formerly referred to as the Nigerian Building Society) and any other person in respect of any of the properties affected by this Decree, the Government of Kaduna State may come to such arrangement with respect to such mortgage with that Bank as that Government may think fit in the circumstances." ; and

(b) for the Schedule to the Decree, there shall be substituted the following new Schedule—

The Decree amends the Forfeiture of Assets (Director of the Special Structures Company Limited) Decree 1977 by substituting the properties known as No. 22 and 22A Gwari Crescent, Kaduna, for the ones mentioned in the Schedule to the principal Decree.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1. Notwithstanding section 52 of the Constitution of former Eastern Nigeria (as modified by the Constitution (Basic Provisions) Decree 1975) and of section 5 of the High Court Law of former Eastern Nigeria as in force in the Rivers State of Nigeria (which provides that any person holding the office of a judge of the High Court of the Rivers State shall vacate that office when he attains the age of 62 years), the person holding the office of Chief Judge of the Rivers State on 24th August 1976 shall continue to hold that office until 24th August 1978.
