

## APPROPRIATION DECREE 1984



## Decree No. 15

[28th May 1984]

ment.

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1.—(1) The Accountant-General of the Federation may when authorised to do so by warrants signed by the Minister of Finance pay out of the Consolidated Revenue Fund of the Federation during the financial year ending 31st December 1984 the sums specified by the warrants, not exceeding in the aggregate Six Billion, Seven Hundred and Forty-three Million, Eight Hundred and Fifty-three Thousand Naira.

Issue and appropriation of ₦6,743,853,000 from the Consolidated Revenue Fund for 1984.

(2) The amount mentioned in subsection (1) of this section shall be appropriated to heads of expenditure as indicated in the Schedule to this Decree.

(3) No part of the amount aforesaid shall be issued from the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.

2. This Decree may be cited as the Appropriation Decree 1984.

## EXPLANATORY MEMORANDUM

*(This note does not form part of this Decree but is  
only intended to explain its effect)*

The Appropriation Decree 1984 (for the period 1st January to 31st December 1984) provides for the issue from the Consolidated Revenue Fund of the Federation of a total sum of ₦6,743,853,000 out of which the sum of ₦6,072,461,420 is for Recurrent Expenditure including Consolidated Revenue Fund Charges while the balance of ₦671,391,580 is the Contribution to the Development Fund for Capital Projects.
