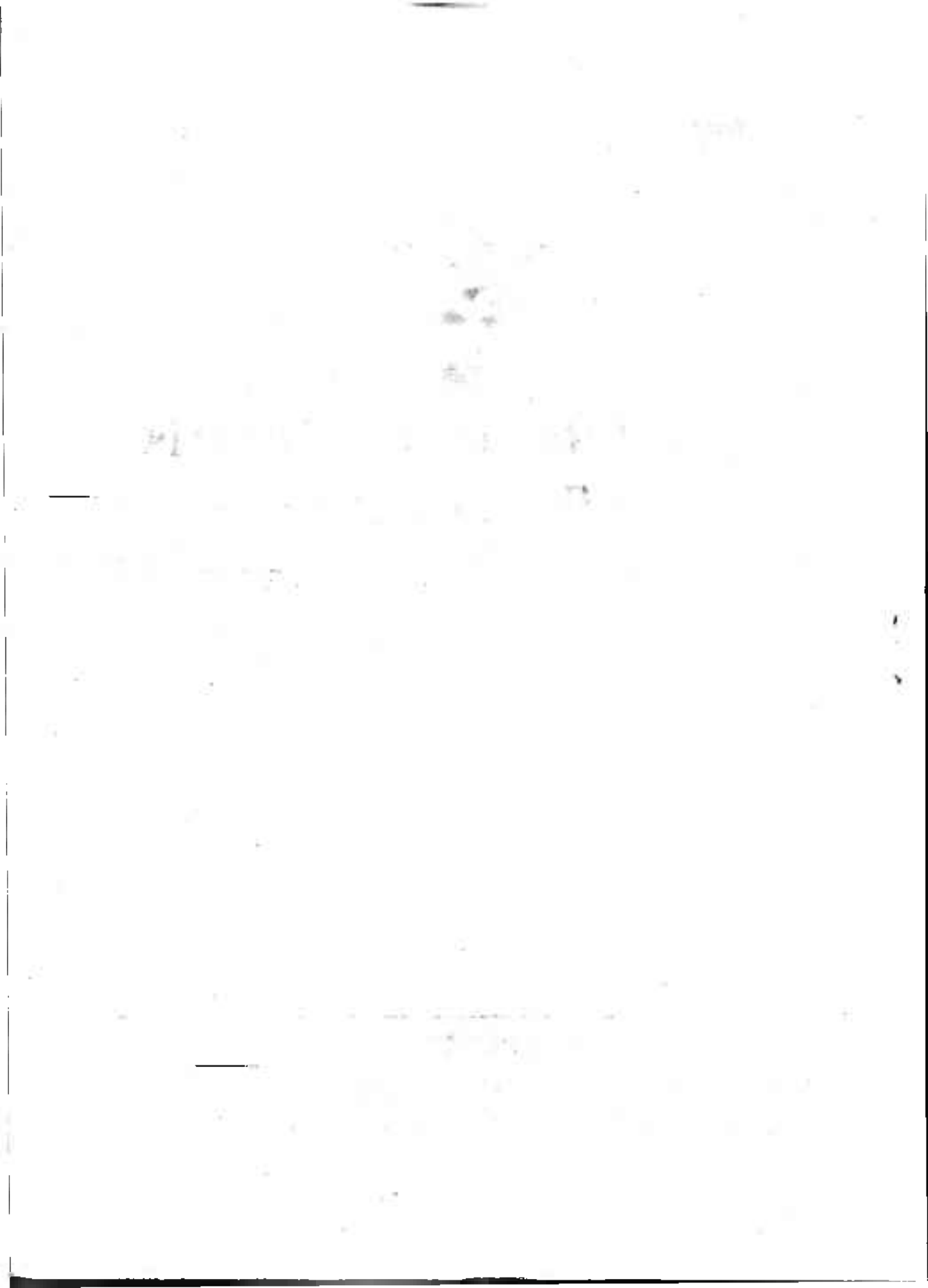

**APPOINTMENT OF THE FIFTH MEMBERS OF THE
GOVERNING BOARD AND REGISTRAR OF THE COUNCIL
OF REGISTERED BUILDERS OF NIGERIA (CORBON)**

The Council of Registered Builders of Nigeria (CORBON) is one of the five (5) Professional Regulatory Bodies under the supervision of the Federal Ministry of Lands, Housing and Urban Development.

2. It was established by Decree No. 45 of 1989 (Now Act B13 LFN 2004) with the statutory mandate to regulate and control the practice of Builders in Nigeria. It is therefore an agency of the Government which performs the following functions :

- (i) Determining who are Builders for the purpose of this Act ;
- (ii) Determining what standards of knowledge and skills are to be attained by persons seeking to become registered as Builders and to review those standards from time to time as circumstances may permit.
- (iii) Securing in accordance with the provision of this Act, the establishment and the maintenance of a register of persons entitled to practice as Builders and the publication from time to time of list of those persons.
- (iv) Regulating and controlling the practice of the Building Technology profession in all its aspects and ramifications.
- (v) Performing such other functions conferred on the council by this Act.

3. The Act provides for a 15-member Governing Board to administer the affairs of the Agency, while it also provides for the employment of a Registrar to oversee the day to day activities of the Agency and Secretary to the Council of the Board.

4. The Current 5th Governing Board was inaugurated for a tenure of four (4) years by the Honourable Minister of Lands, Housing and Urban Development on the 28th of February, 2013.

5. As a statutory Agency of the Federal Government under the supervision of Ministry of Lands, Housing and Urban Development, I wish to convey to you the approval that the appointment of the following members of the Governing Board of Council of Registered Builders of Nigeria (CORBON) should be officially published in the Federal Government Official *Gazette* meant for that purpose.
