LEGAL NOTICE NO. 115 OF 1976

THE GRADED TAX ACT, 1968

(No. 39 of 1968)

THE GRADED TAX (AMENDMENT) REGULATIONS, 1976

(Under Section 20)

(Date of commencement: 24th December, 1976)

In exercise of the powers conferred upon him by the abovementioned Act, the Honourable the Minister for Finance and Economic Planning is pleased to make the following regulations —

*Citation.*

1. These regulations may be cited as the Graded Tax (Amendment) Regulations, 1976.

*Interpretation.*

2. In these regulations any regulation referred to is a regulation of the Graded Tax Regulations, 1968.

*Amendment or regulation 8(c).*

3. Regulation 8(c) is amended by deliting the words "if available"

*Addition of the following new regulations 11 and 12 and their subheadings*

*Application for registration as a graded taxpayer.*

11. Every person who has attained the age of 18 years and is resident or domiciled in Swaziland shall apply to a collector for registration as a graded taxpayer by presenting himself together with the Swazi authority under whom he falls or, if there is no such Swazi authority, by filling in Form 168R and presenting it, to such collector.

*Duties of collectors on receipt of applications.*

12. Every collector to whom an application has been made under regulation 11 shall register such applicant as graded taxpayer, allot a graded tax number to him and issue to him a registration certificate of first payment of graded tax by him.

LEGAL NOTICE NO. 116 OF 1976

THE FARM DWELLERS ACT, 1967

(No. 21 of 1967)

CURRENT RATES OF WAGES FOR FARM LABOUR  
REGULATIONS, 1976

(Under section 15(e) )

(Date of commencement: 24th December, 1976)

In exercise of the powers conferred upon him by the above-mentioned Act, the Honourable the Minister for Local Administration is pleased to make the following regulations —

*Citation.*

1. These regulations may be cited as the Current Rate of Wages for Farm Labour Regulations, 1976.

*Interpretation.*

2. In these regulations unless the context otherwise requires —

“farm labour” means a person who works on a farm otherwise than pursuant to an Agreement entered into in terms of the Farm Dwellers Act No. 21 of 1967;

“regulation of wages (agricultural industry) Order” means the Regulation of Wages (Agricultural Industry) Order, 1975, published in Legal Notice No. 5 of 1975 as amended.

*Application of Regulations of Wages (Agricultural Industry)  
Order to Farm Labour.*

3. Regulations of Wages (Agricultural Industry) Order shall apply to farm labour.
