LEGAL NOTICE NO. 107 OF 1982

THE POST OFFICE ACT, 1962

(Act No. 60 of 1962)

THE POSTAL (AMENDMENT) (NO. 2) REGULATIONS, 1982

(Under regulation 4)

In exercise of the powers conferred by regulation 4 of the Post Office Regulations, 1962 the Minister for Works, Power and Communications hereby makes the following Regulations:—

Citation.

1. These Regulations may be cited as the Postal (Amendment) (No. 2) Regulations, 1982, and shall be read as one with the Post Office Regulations, 1962.

Amendment of Schedule B.

2. Schedule B of the Post Office Regulations, 1962 is amended in Part IIIA and Part IIIB by replacing the postage rates therein with the rates in the Schedule hereto.
