(Under Section 73)**

In exercise of the powers conferred on me, I, SOZISA AUTHORISED PERSON of the Kingdom of Swaziland, am pleased to assign to the Ministers listed in the schedule hereto, the responsibilities for the conduct of such business of the Government of Swaziland as is specified under each such Minister with effect from the 21st November, 1983.

In addition, each such Minister shall be responsible for the efficient carrying out of any functions which may be assigned to him by law for the time being in force in Swaziland.
