MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to amend the Treasury Bills and Short Dated Government Stocks Order, 1973 (King's Order-in-Council No. 23 of 1973) so as to raise the ceiling of Government borrowing by the issue of short dated Government stocks from E50,000,000 to E100,000,000 at any one time.

An Act to amend the Treasury Bills and Short Dated Government Stocks Order, 1973.

Short title.

1. This Act may be cited as the Treasury Bills and Short Dated Government Stocks (Amendment) Act, 1987 and shall be read as one with the Treasury Bills and Short Dated Government Stocks Order, 1973.

Amendment of section 4.

2. Section 4 of the Treasury Bills and Short Dated Government Stocks Order, 1973 is replaced with the following—

“4. The maximum amount of funds which may be borrowed under this Order at any one time shall not exceed E100,000,000.”
