LEGAL NOTICE NO. 18 OF 1987

THE FINANCIAL INSTITUTIONS (CONSOLIDATION) ORDER, 1975
(Order No. 23 of 1975)

THE PRESCRIPTION OF MINIMUM LIQUID ASSETS NOTICE, 1987
(Under Section 22)

In exercise of the powers conferred by Section 22 of the Financial Institutions (Consolidation) Order, 1975, I hereby issue the following Notice —

Citation.

1. This Notice may be cited as the Prescription of Minimum Liquid Assets Notice, 1987 and shall come into force on the 1st June 1987.

Prescription of Minimum Liquid Assets.

2. The Central Bank of Swaziland hereby prescribes that a financial institution licensed under Section 6 of the Financial Institutions (Consolidation) Order, 1975 shall maintain liquid assets amounting to not less than 10 per cent of savings deposits and of deposits with original maturity of one year or more plus 25 per cent of all other deposits, as shown in the preceding monthly statement submitted to the Central Bank under Section 31 of the Order.

Revocation of Legal Notice No. 124 of 1982.

3. The Prescription of Minimum Liquid Assets Notice, 1982 is hereby revoked.
