LEGAL NOTICE NO. 60 OF 1987

THE WATER ACT, 1967

(Act No. 25 of 1967)

EXEMPTION PERMIT (NATIONAL TEXTILE CORPORATION OF SWAZI-
LAND LIMITED) NOTICE, 1987

(Under Section 18)

In exercise of the powers conferred by section 18 of the Water Act, 1967 the Water Apportionment Board hereby issues the following Notice—

Citation.

1. This Notice may be cited as the Exemption Permit (National Textile Corporation of Swaziland Limited) Notice, 1987.

Summary of permit.

2. The National Textile Corporation of Swaziland Limited, is exempted from complying with the provisions of section 18(2) and (3) of the Water Act, 1967 and the Purification of Industrial Water and Effluent Regulations, 1967 subject to the following—

- (a) A storage facility, sufficient to hold effluent resulting from three days of operation, shall be constructed within the factory premises.
- (b) The partially treated effluent shall be piped from the factory up to the point of discharge into the Lusushwana river (Mkimkomo weir).
- (c) No effluent may be discharged from 2100 hours on Friday through to 0400 hours on Monday; and at times, the hours of discharge might be varied to suit the proper operation of the weir.
- (d) The effluent shall be discharged at a uniform rate, expressed in litres per second.
- (e) The effluent, after discharge and dilution with river water, will change the quality of river water as follows—
 - (i) Chemical oxygen demand — will be increased by not more than 4 mg/l
 - (ii) Sodium, Na — will be increased by not more than 13 mg/l
 - (iii) Total dissolved solids, TDS — will be increased by not more than 30 mg/l
 - (iv) Suspended solids — will be increased by not more than 2 mg/l
- (f) The Lusushwana river shall be sampled daily by the Company at the following points—
 - (i) Just downstream of the point of discharge of effluent from the Matsapha effluent treatment ponds.
 - (ii) At the inlet into the Swaziland Electricity Board Canal.

(g) The Company shall make the following daily determinations on samples obtained from the sampling points—

- (i) pH
- (ii) Sodium
- (iii) Chemical oxygen demand
- (iv) Total dissolved solids
- (v) Suspended solids

(h) Duplicate reports shall be submitted every six months by the Company to the Water Resources Branch for examination.

N.B. A minimum dilution flow of 1 cubic metre per second has been assumed for the Lusushwana at Matsapha bridge (River Gauge Station No. 2).

Notification to Board.

3. Any interested person may, within 30 days of the publication of this Notice, notify the Board in writing of his intention to present such evidence as is relevant to the said application and such person shall there-upon be entitled to appear before the Board and present such evidence in person or through witnesses called by him.

Any notification to the Board shall include a statement indicating the nature of the evidence which is to be presented.
