## GENERAL NOTICE NO. 37 OF 1990

## THE SWAZILAND RAILWAY ACT, 1962

(Act No. 15 of 1962)

## THE BOARD OF ENQUIRY (SWAZILAND RAILWAY) NOTICE, 1990

(Under Section 44)

1. (1) It is hereby notified that in exercise of the powers conferred upon me by section 44 of the Swaziland Railway Act of 1962, I, Wilson, F.C. Mkhonza, hereby appoint a Board of Enquiry to investigate the causes of the train accident which occurred on the 19th June, 1990 between Mpaka and Phuzumoya Stations.

(2) The Board shall consist of the following members:-

2. *Terms of Reference of the Board*

1. To investigate the causes of the train accident on the Mpaka - Phuzumoya junction on 19 June 1990.
2. To advise on the implications of such an accident.
3. To recommend ways and means of preventing a re-occurrence of an incident of this type.
4. To make other recommendations as may seem necessary.

*Enquiry Venue*

1. The enquiry shall be held at Mpaka or such other place as the Presiding Officer may decide.
2. The enquiry shall be open to the public provided that no employee of the Swaziland Railway shall attend the proceedings unless so directed by the Board.

*Board to subpoena witnesses*

The Board shall have the power to subpoena such witnesses as it deems necessary.

5. *Duration of Enquiry*

The Board shall commence its functions on the 5th July, 1990 and submit its report to the Minister for Works and Communications by 26th July, 1990 or on such later date as the Minister for Works and Communications may permit in writing.
