LEGAL NOTICE NO. 135 OF 1992

THE WAGES ACT, 1964

THE APPOINTMENT OF MEMBERS OF THE WAGES COUNCILS NOTICE, 1992

(Under Section 6)

In exercise of the powers conferred on him by Section 6 of the Wages Act, 1964 I, the Minister for Labour and Public Service hereby make the following notice:-

*Citation and Commencement.*

1. This notice may be cited as the Appointment of Members of the Wages Councils Notice, 1992 and shall be deemed to have come into force on the 1st May, 1992.

*Appointment of Members.*

2. (a) The following persons are hereby appointed to be members of the following wages councils for a period of three years, with effect from 1st May, 1992 to 30th April, 1995.

(b) Any Independent Member, can act as Chairman of Councils at any meeting, in that particular Industry.
