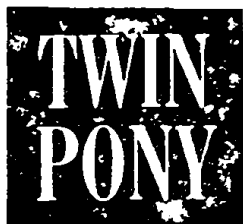

**The Traffic and Road Safety (Speed of Motor Vehicle)  
(Exemption) (No. 4) Order, 2004.**

*(Under section 136 of the Traffic and Road Safety Act, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 136 of the Traffic and Road Safety Act, this Order is made this 23rd day of April, 2004.

1. This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 4) Order, 2004.

Citation.

2.
