IN EXERCISE of the powers conferred upon the Electoral Commission by section 19(8)(c) of the Electoral Commission Act, Cap 140, this Instrument is made this 20th day of August, 2007.

1. Title.

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Nakapiripirit District) Instrument, 2007.

2. Appointment of date of completion.

The 31st day of August, 2007, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-election in Nakapiripirit District.

3. No application accepted after appointed date.

For purposes of paragraph 2 of this Instrument, after the appointed date, no application form from Nakapiripirit District shall be accepted by the Electoral Commission, seeking—

- (a) to register as a voter; or
- (b) to transfer to a new voting location.
