The Police (Restructuring of Rank) Order, 2008.

(Under section 9(1) (f) of the Police Act, Cap. 303).

IN EXERCISE of the powers conferred on the Police Authority by section 9(1) (f) of the Police Act, this Order is made this 10th day of July, 2008.

1. Title.

This Order may be cited as the Police (Restructuring of Rank) Order, 2008.

2. Adoption of the rank of Senior Commissioner of Police (SCP).

(1) The rank of Senior Commissioner of Police is adopted.

(2) The terms and scale of a Senior Commissioner of Police shall be equivalent to those of a Deputy Director in the public service.
