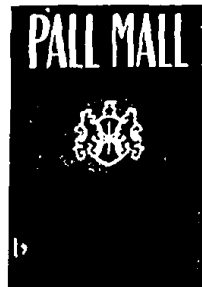



**The Local Governments (Declaration of Towns) Regulations, 2009.**

*(Under sections 7(3) and 175(1) of the Local Governments Act, Cap. 243)*

IN EXERCISE of the powers conferred upon the Minister responsible for local governments by sections 7(3) and 175(1) of the Local Governments Act, in consultation with the districts and with the approval of Cabinet, these regulations are made this 8th day of May, 2009.

**1. Title.**

These regulations may be cited as the Local Governments (Declaration of Towns) Regulations, 2009.

**2. Declaration of Towns.**

The following areas are declared to be towns—

- (a) Buliisa —consisting of Northern, Western, Central and Eastern Wards in Buliisa District;
- (b) Bududa —consisting of Nashuia, Buloli and Buwanambisi Wards in Bududa District;
- (c) Oyam —consisting of Western and Eastern Wards in Oyam District;
- (d) Lwakhakha —consisting of Bukibayi, Bukhoma, Bukemo, Buwuma, Butemulani and Lwakhakha Wards in Lwakhakha District;
- (e) Nakaseke } —consisting of Butalangu, Bukoba, Kyanya Parishes  
Butalangu and Bwetagi Ward in Nakaseke District.
