MINISTERIAL POLICY DIRECTION ON MERGING
UGANDA COMMUNICATIONS COMMISSION (UCC) WITH
BROADCASTING COUNCIL (BC)

WHEREAS H.E. The President of the Republic of Uganda directed the Minister of Information and Communications Technology under Article 99 (1) of the 1995 Constitution of the Republic of Uganda, to have the Uganda Communications Commission and the Broadcasting Council merged;

AND WHEREAS a decision of Cabinet Under Minute 168 CT (2007) of 25th April 2007 mandated the Ministry of ICT to:

- (i) Constitute a multi institutional committee of which UCC and BC were members to oversee the merger process;
- (ii) Take-over management of the National Spectrum (Airwaves) and the transmission infrastructure from the Ministry of Information and National Guidance (MING).

NOW THEREFORE in accordance with the said Cabinet decision under Minute 168 CT (2007) of 25th April 2007, and H.E. the President's directive of 18th December 2009, given under Article 99(1) of the 1995 Constitution in the exercise of his Executive Authority, I hereby in exercise of the powers conferred upon the Minister under the Uganda Communications Act 1997 Section 12 and the Electronic Media Act 1997 Section 9(5),

(A) Direct that the Uganda Communications Commission and the Broadcasting Council establish one administrative structure on this 15th day of March 2010 under the following guidelines:

1. The transitional body shall be merged at both the Board and Administrative levels. The Primary role of the transitional Board and Executive shall be to oversee and conclude the process of drafting the law and establishing the merged regulator for both communications and broadcasting in accordance with best the practices and international standards.
2. The transitional body shall be headed by a Board comprising of members from the two existing Boards of the merging organizations and will be headed by the current Chairperson of the Uganda Communications Commission, Eng. Dr. A. M. S. Katahoire.

3. The transitional Board is hereby mandated to form working committees for the efficient discharge of its duties.
4. While the Board will oversee the process of merging the two regulators, it will also continue to carry out the functions specified in the Uganda Communications Act 1997 and Electronic Media Act 1997. Where the functions require specific focus, pertaining to communications, the members who were Commissioners under UCC may constitute themselves into a Communications Committee to handle the matter and will keep the Board updated. Where the matter pertains to Broadcasting, members who were members of the Board of Broadcasting Council will constitute themselves into a Broadcasting Committee and keep the Board updated accordingly.
5. The transitional body will be headed by the Chairperson of Broadcasting Council, Eng. Godfrey Mutabazi as the Administrative Head.
6. The Broadcasting Council and the Uganda Communications Commission are instructed to work out the administrative details of the new structure and modalities of operation.
7. The transitional body shall continue to carry out the functions of both regulators until the functions of the merged regulator are provided for by the new law.
8. The two laws that is, Uganda Communications Act 1997 and the Electronic Media Act 1997 shall continue to exist and provide the regulatory framework for regulating the transitional merger until a new Converged Legislation is enacted.
9. The Uganda Communications Commission and the Broadcasting Council may conclude the details of this arrangement through a memorandum of understanding on the modalities of the day to day operations.

(B) Take-over management of the National Spectrum (Airwaves) and the transmission infrastructure from the Ministry of Information and National Guidance.

This Policy Guideline may be cited as the Uganda Communications (Transitional Converged Regulator Policy) Guideline, 2010 and shall come into force on 15th March 2010.
