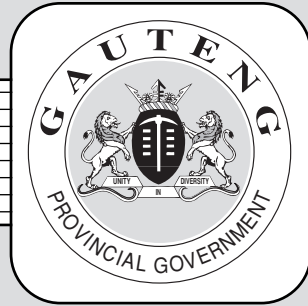

CORRECTION NOTICE

The City of Johannesburg Metropolitan Municipality herewith gives notice in terms of the provisions of Section 80 of the Town Planning and Townships Ordinance, 1986, as amended, that Local Authority Notice 1645 dated 19 December 2012 in respect of **Laser Park extension 36**, has been amended as follows:

A. THE ENGLISH NOTICE:

1. By the substitution of clauses 2 with the following:

“(2) ERVEN 246 AND 247

The local authority had limited the electricity supply to the erf to 315KVA.
