
**REMUNERATION OF PUBLIC OFFICE BEARERS ACT, 1998

**DETERMINATION OF SALARIES AND ALLOWANCES OF MEMBERS OF THE  
EXECUTIVE COUNCIL AND THE DIFFERENT MEMBERS OF THE PROVINCIAL  
LEGISLATURE: GAUTENG PROVINCE**

In terms of section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998), read with Proclamation No. 5 of 2015, promulgated in *Government Gazette* No. 38470 on 13 February 2015 by the President of the Republic of South Africa, I hereby determine that the total remuneration of the positions of office bearers in Column 3 of the Schedule shall be as set out in Column 4 of the Schedule with effect from 1 April 2014, subject to the terms and conditions set out in the said Proclamation.

The Premier's Notice No. 1 of 2014, promulgated in the *Provincial Gazette* No. 15 of 24 January 2014, is hereby repealed.
