**KWAZULU-NATAL PROCUREMENT ACT REPEAL ACT, 2005**  
(Act No. 4 of 2005)  
Assented to on 2005-12-01

**ACT**

**To provide for the repeal of the KwaZulu-Natal Procurement Act, 2001; and to provide for matters connected therewith.**

BE IT ENACTED by the Legislature of the Province of KwaZulu-Natal, as follows: —

**Repeal of laws**

1. The KwaZulu-Natal Procurement Act, 2001 (Act No. 3 of 2001), and the KwaZulu-Natal Procurement Amendment Act, 2001 (Act No. 6 of 2001), are hereby repealed.

**Transitional provision**

2. Any procurement process commenced with before the commencement of this Act in terms of the repealed KwaZulu-Natal Procurement Act, 2001 (Act No. 3 of 2001), and the regulations made in terms of that Act, must be finalised as if this Act had not come into operation.

**Short title**

3. This Act is called the KwaZulu-Natal Procurement Act Repeal Act, 2005.

DAAR WORD soos volg deur die Wetgewer van die Provinsie KwaZulu-Natal bepaal: —

**Herroeping van wette**

1. Die KwaZulu-Natal Verkrygingswet, 2001 (Wet No. 3 van 2001) en die Wysigingswet op die KwaZulu-Natal Verkrygingswet, 2001 (Wet No. 6 van 2001) word hierby herroep.

**Oorgangsbepaling**

2. Enige verkrygingsproses waarmee begin is voor die inwerkingtreding van hierdie Wet ingevolge die KwaZulu-Natal Verkrygingswet, 2001 (Wet No. 3 van 2001), en die regulasies wat ingevolge daardie Wet uitgevaardig is, moet gefinaliseer word asof hierdie Wet nie in werking getree het nie.

**Kort titel**

3. Hierdie Wet heet die Herroepingswet op die KwaZulu-Natal Verkrygingswet, 2005.
