No. 3, 2018**AMENDMENT OF TERMS OF REFERENCE OF PROCLAMATION ESTABLISHING COMMISSION OF ENQUIRY INTO UNDERLYING CAUSES OF THE MURDER OF POLITICIANS IN KWAZULU-NATAL IN TERMS OF SECTION 127(2)(e) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996, READ WITH SECTION 2(1) OF THE KWAZULU-NATAL COMMISSIONS ACT, 1999**

In terms of section 127(2)(e) of the Constitution of the Republic of South Africa, 1996, read with section 2(1) of the KwaZulu-Natal Commissions Act, 1999 (Act No. 3 of 1999), I hereby amend the Terms of Reference of the Commission of Enquiry into the Underlying Causes of the Murder of Politicians in KwaZulu-Natal, as set out in Part A of the Schedule to Proclamation No. 1 of 2016, as published in KwaZulu-Natal *Extraordinary Provincial Gazette* Number 1748 of 28 October 2016, as follows –

(a) by the substitution for item 3 of the Terms of Reference of the following item:

“3. The provisions of the KwaZulu-Natal Commissions Act, 1999, are applicable to the Commission: Provided that the Commission must produce and submit its final detailed report containing a summary of evidence, its findings and recommendations no later than nineteen months after the date of this Proclamation.”; and

(b) by the substitution for item 5 of the Terms of Reference of the following:

“5. The Commission must submit interim reports and recommendations to the Premier each month prior to the final report being presented to the Premier. The Commission must complete its work within a period of eighteen months from the date of this Proclamation and must submit its final report to the Premier within a period of one month after the date on which the Commission completes its work.”.
