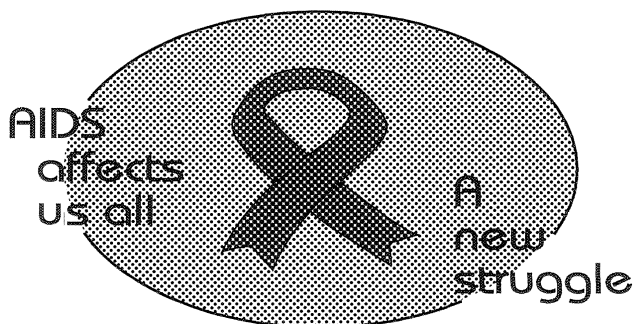



GENERAL NOTICE**GENERAL NOTICE 18 OF 2015****DEVELOPMENT FACILITATION ACT, 1995 (ACT NR 67 OF 1995)**

It is hereby notified in terms of Section 33 (4) of the above-mentioned Act that the Limpopo Province Development Tribunal has approved a Land Development Application for Thohoyandou JK Extension 1 on the farm Mpabase 451, Registration Division M.T., Limpopo Province, in extent 82,7567 hectares (Thulamela Local Municipality) subject thereto that:

1. The National Building regulations are applicable to the development;
2. The Partial cancellation of General Plan SGV44/1990 (General Plan of Erven 1313 up to 1322 and 1324 Thohoyandou J) is hereby granted;
3. The partial cancellation of General Plan SGV124/1990, SG5377/2000 (General Plan of Erf 1 Thohoyandou K and the sub divisional plan of Erf 1 Thohoyandou K) is hereby granted;
4. The closing of Erven 1321, 1322 and 1324 Thohoyandou J as park sites and the closure of a section of road within Thohoyandou J is hereby granted.
5. That the Thulamela Townplanning Scheme, 2010 be amended in terms of the conditions of establishment which will come into operation on date of publication of this notice.
