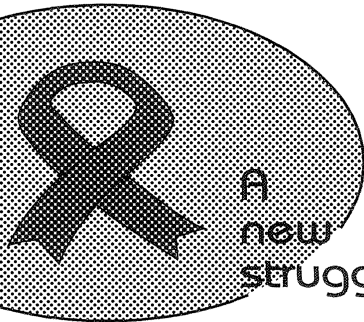

Notice is hereby given in terms of section 49, 1 (a) (i) of the Local Government: Municipal Property Rate Act, Act no 6 of 2004, hereinafter referred to as the "Act", that the General Valuation Roll for the financial year 2014/2018 is open for public inspection at the offices and libraries within DR JS Moroka Local Municipality from the **14 July to 9 August 2014**.

An invitation is hereby made in terms of section 49 (1) (a) (ii) of the Act that any owner of the property or any person who so desires can lodge an objection with the Municipal Manager in respect of any matter reflected herein , or omitted from the valuation roll within the above mentioned period.

Attention is drawn to the fact that in terms of section 50 (2) of the Act, an objection must be in relation to a specific individual property and not against the valuation roll as a whole.
