CALL FOR OBJECTIONS IN RESPECT OF APPOINTMENTS TO THE MPUMALANGA  
ECONOMIC REGULATOR BOARD

I, Sikhumbuzo Eric Kholwane, Member of the Executive Council responsible for the administration of the Mpumalanga Economic Regulator Act, 2017 (Act no. 02 of 2017), hereby give notice of my intention to appoint the persons listed below to serve as non-Executive Members to the Mpumalanga Economic Regulator Board with effect from **01 April 2018**.

In accordance with section 7(3) of the Act, the following appointments are proposed:

Sec 5(1)(a) – a Chairperson, designated by the responsible Member from amongst the Members of the Board referred to in paragraphs (c), (d), (e), (f) and (j), who shall be a person with applicable knowledge or experience with regard to matters connected with the functions of the Board – **Mr. Mdoda Eric Mbhele (I.D. No. 5612125887080)**;

Sec 5(1)(b) - a Deputy Chairperson, designated by the responsible Member from amongst the Members of the Board referred to in paragraphs (c), (d), (e), (f) and (j) – **Mr. Protas Langalakhe Mhlongo (I.D. No. 6409245683088)**;

Sec 5(1) (c) - one member who is qualified to be admitted to practice as a legal practitioner in the Republic and has, for a cumulative period of at least five years after having so qualified, practised as a legal practitioner or performed services related to the application or administration of the law – **Ms. Thembi Esenat Mawebele (I.D. No. 7906070524088)**;

Sec 5(1)(d) - one member who is qualified as an accountant in the Republic and has, for a cumulative period of at least five years after having so qualified, practised as an accountant and who shall be registered as a member of a relevant professional body – **Mr. Phumlani Ennocent Eugene Mntambo (I.D. No. 8403045816087)**;

Sec 5(1) (e) - one member who shall have proven business acumen in, and knowledge of, the gambling industry – **Ms. Gaylene Anne Deiner (I.D. No. 5401210113085)**;

Sec 5(1) (f) - one member who shall have proven business acumen in, and knowledge of, the liquor industry – **Dr. Thabo Ntobeko Mzoneli (I.D. No 8210095587082)**;

Sec 5(1)(j) - with due regard to regional interests in the Province, not more than three members who shall have proven business acumen or applicable knowledge or experience in the field of local government, community and socio-economic development and who are fit and proper to represent the community in general – **Ms. Nombuso Fikile Mabuza (I.D. No. 8102050479084)**

In accordance with section 7(3)(b) of the Act, any person who desires to object to the appointment of any of the aforementioned person(s) to the Board, may, not later than 14 days before the date on which the appointment of the members of the Board is intended to be made, lodge with the MEC responsible for administration of the Mpumalanga Economic Regulator Act, 2017, in writing an objection stating the ground or grounds which, according to such a person disqualifies the person to be appointed, from being appointed as a member to the Board.
