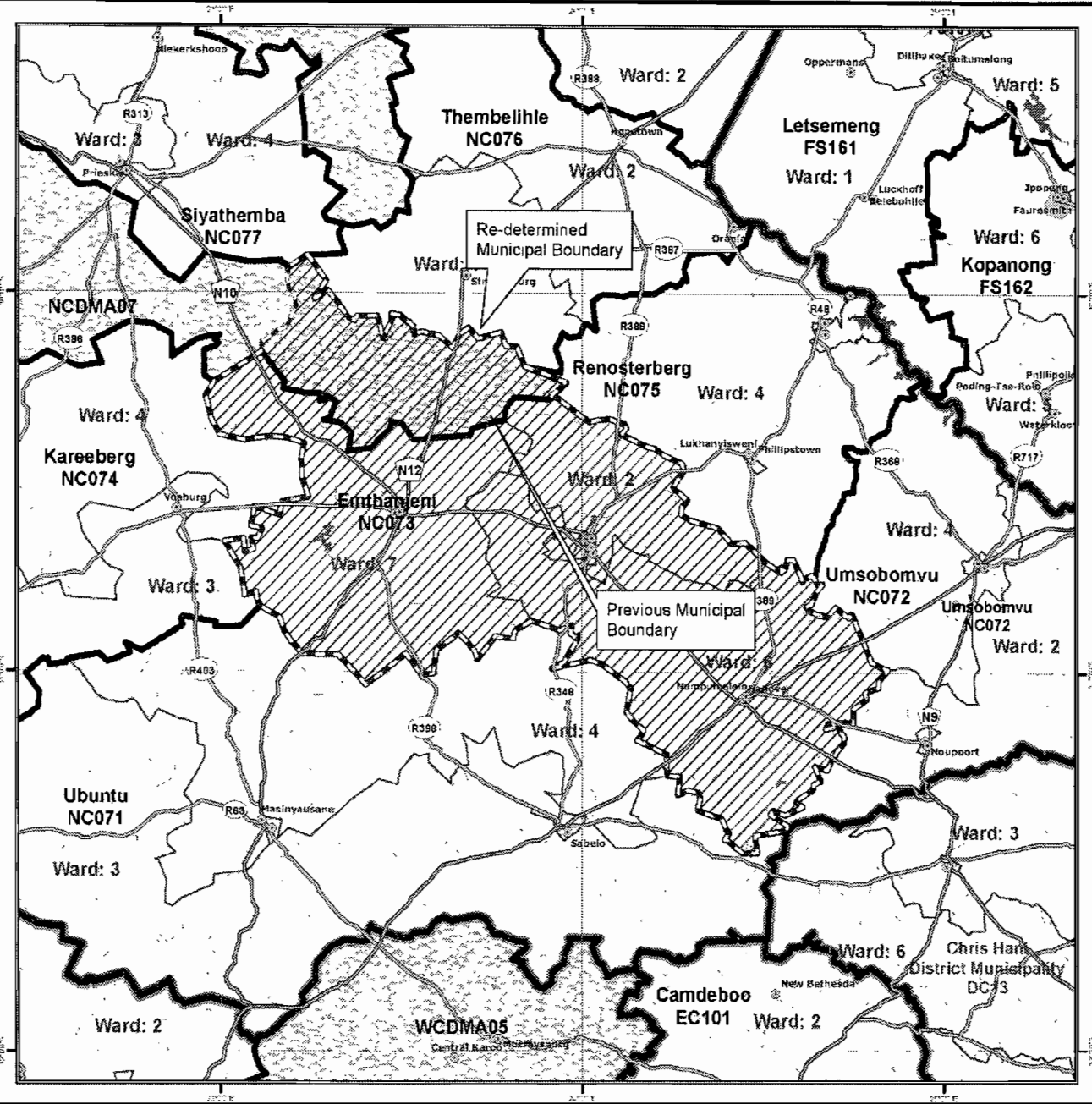
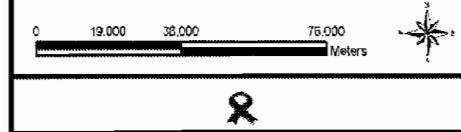


Re-determination of muncial bouaries by including the eastern portion of NCDMA07, east of the N10 national road into Emthanjeni Local Municipality (NC073)

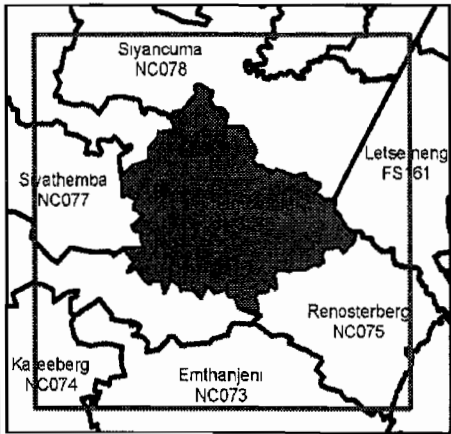

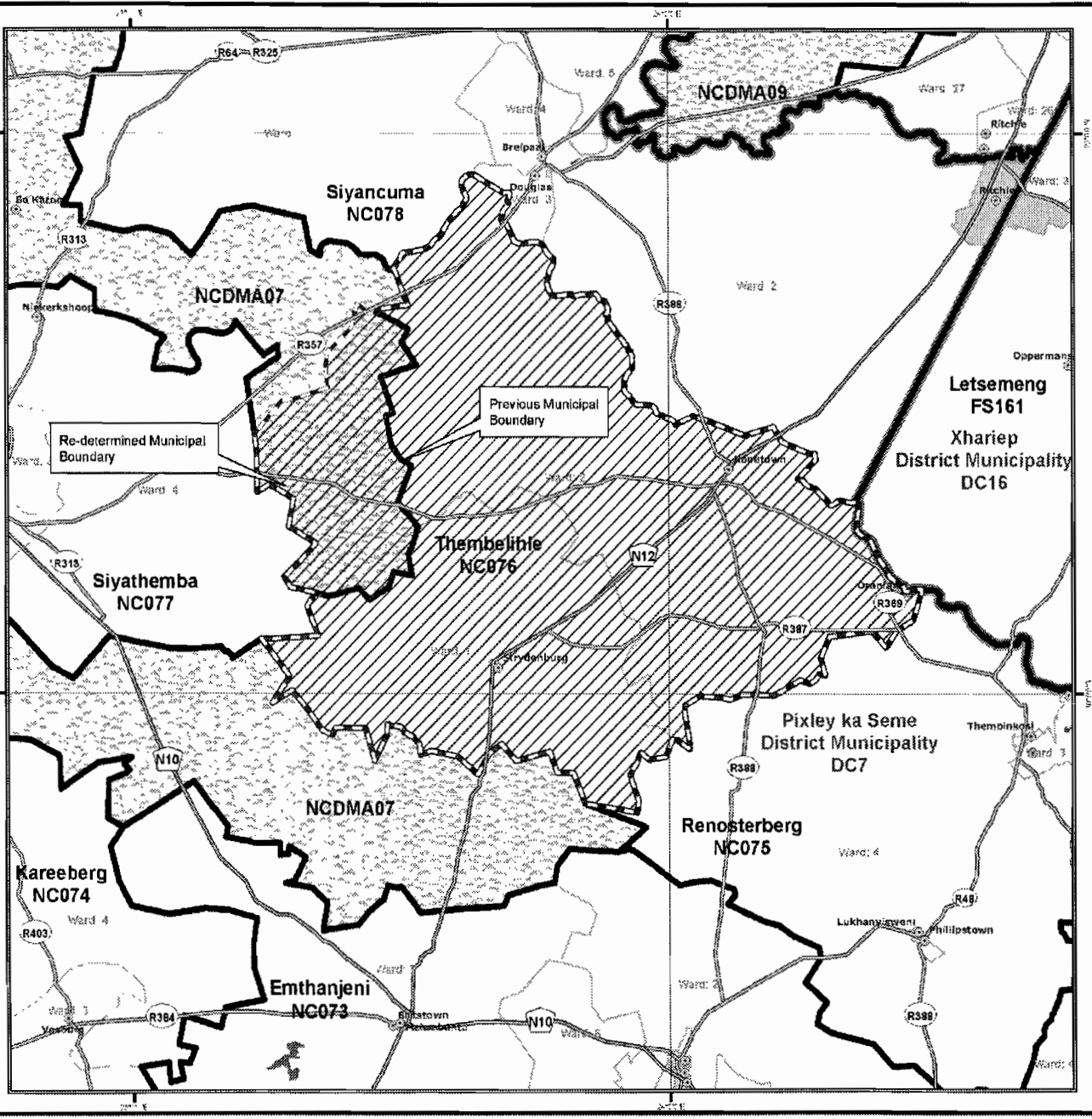

Re-determination of municipal boundaries by including the portion of NCDMA07 east of the R357 into Thembelihle Local Municipality (NC076)

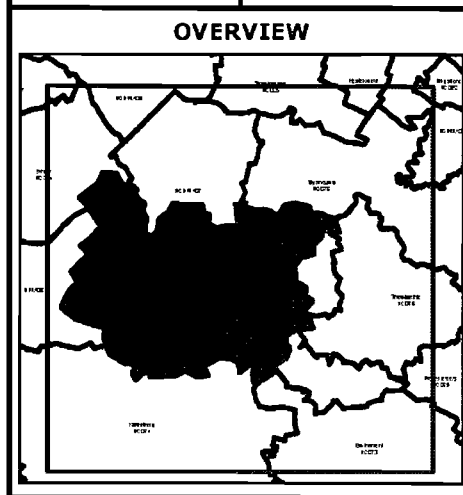

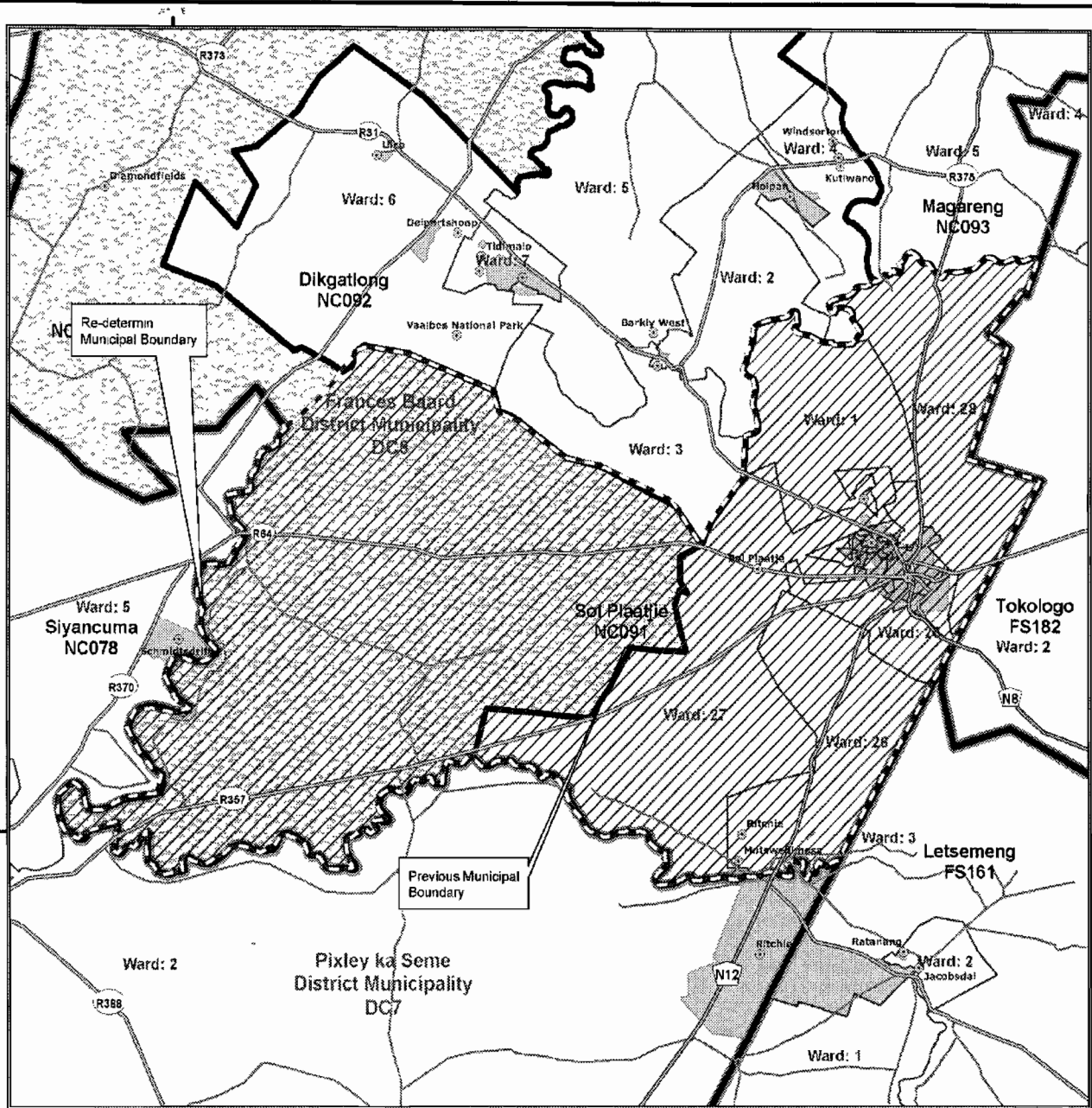
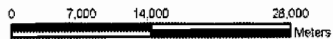
Re-determination of municipal boundaries by including lower southern portion of NCDMA09, south of the Vaal river into Sol Plaatjie Local Municipality (NC091)
