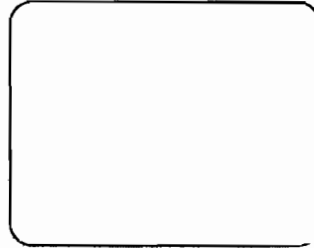

PUBLIC NOTICE CALLING FOR INSPECTION OF SUPPLEMENTARY VALUATION ROLL AND LODGING OF OBJECTION

Notice is hereby given in terms of section 49 (1)(a)(i) read together with section 78(2)* of the Local Government: Municipal Property Rates Act, 2004 (Act 6 of 2004), hereinafter referred to as the "Act", that the supplementary valuation roll for the financial years 1 July 2012 to 30 June 2015 is open for public inspection at the Siyancuma Local Municipality, Charl Cilliers Street, Civic Centre, Douglas from 8 March 2012 to 23 April 2012 (Monday to Friday between 07:00 to 16:00).

An invitation is hereby made in terms of section 49(1)(a)(ii) read together with section 78(2)* of the Act that any owner of property or other person who so desires should lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the supplementary valuation roll* within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the supplementary valuation roll* as such.

The form for the lodging of an objection is obtainable at the Property Rates Division (Finance Department) at the Siyancuma Municipality, Charl Cilliers Street, Civic Centre, Douglas.
